#### PNB RANKS 1ST IN IMPLEMENTATION OF 'REFORMS AGENDA'

According to BCG-IBA Report – EASE Reforms for Public Sector Banks, released by Union Minister of Finance & Corporate Affairs, Punjab National Bank (PNB) secured the top spot among all public sector banks in the implementation of 'Reforms agenda'.

PNB which topped the list with a score of 78.4 out of 100 in the EASE-index was followed by BoB (77.8), SBI (74.6), and Oriental Bank of Commerce (69).

The EASE (Enhanced Access and Service Excellence) report has shown significant enhancement in PSB performance on the back of Government's 4R's strategy- recognition, recovery, recapitalisation and reforms. The index has measured Banks on 140 objective metrics across 6 themes including customer responsiveness, credit off-take and digitalization.

# Government of India and ADB sign \$926 Million Loan Agreement for Mumbai Metro Rail Project

The Asian Development Bank (ADB) and the Government of India signed a \$926 Million Loan Agreement to operationalize two lines for the Mumbai Metro Rail System that will ease the distress of millions of commuters each day and help provide a cleaner, less congested city.

The Single Largest Infrastructure Project Loan in ADB history approved by the ADB Board will help fund lines 2A (Dahisar to D.N. Nagar), 2B (D.N. Nagar–Bandra–Mandale), and 7 (Dahisar [East] to Andheri [East]), totaling about 58 kilometers (km).

# Usha Thorat-led task force to ensure stability of external value of rupee

The Reserve Bank of India has constituted an eight-member task force on offshore rupee markets, headed by Usha Thorat, former Deputy Governor, to look

into issues related to the markets and recommend appropriate policy measures to ensure the stability of the external value of the rupee.

# IDBI Bank gets govt nod to handle import, export transactions with Iran

The IDBI Bank has received government nod to handle import and export transactions with Iran, a move which would help in promoting two-way trade amid US sanctions on the Persian Gulf nation.

Iran is India's third-largest oil supplier after Iraq and Saudi Arabia. It was India's second biggest supplier of crude oil after Saudi Arabia till 2010-11 but sanctions by the West over its suspected nuclear programme relegated it to the seventh spot in the subsequent years. In 2013-14 and 2014-15, India bought 11 million tonnes (MT) and 10.95 MT of crude, respectively from Iran.

#### ICICI Bank to buy 9.9% in NBFC Kisan Finance for Rs18 crore

ICICI Bank said it will acquire 9.9% stake in non-banking finance company Kisan Finance for cash consideration of Rs 17.82 crore. The acquisition is expected to be over by the end of March 2019,

Kisan Rural Finance Ltd (Kisan Finance), was incorporated in December 2017. The company had registered a net loss of ₹48 lakh in 2017-18 at a revenue of Rs4 lakh.

## India home to 22 of the Top 30 Most Polluted Cities

As per reports by IQ Air Visual and Greenpeace, the battle of South-Asia regarding the deteriorating air quality and the global climate accord. India is said to be comprised of seven of the top 10 of the most polluted cities existing in the world. Gurgaon located in the capital of India New Delhi, is the most polluted city in the world.

The index measures the presence of PM 2.5 which is a pollutant which can go deep in the lungs and bloodstream of a human being causing several respiratory and other lung diseases. Along with the death toll arising with these pollution figures, there's an estimated cost of USD 225 billion in lost labour and trillions in medical costs. India has 22 of the top 30 most polluted cities in the world with China having 5, Pakistan with 2 and one in Bangladesh.

#### **LIC Housing-IMGC Partnership**

LIC Housing Finance has partnered with India Mortgage Guarantee Corporation (IMGC) to offer special loan scheme, under which borrowers can repay the amount till the age of 75 years.

Under the new partnership, IMGC will provide LICHFL with mortgage guarantee which is a kind of financial product that compensates financial institutions for losses that may arise from a default on a mortgage loan, LICHFL said in a release. This strategic tie-up will help the LICHFL to accommodate more home loan borrowers, increase market penetration besides combating NPAs.

#### SBI, Hitachi arm to roll out digital payments platform

State Bank of India (SBI) and Hitachi Payment Services Pvt Ltd, a wholly-owned subsidiary of Hitachi Ltd, launched their merchant-acquiring joint venture, SBI Payment Services Pvt Ltd (SBIPSPL), in Mumbai, for establishing a digital payments platform for India and other countries in the region.

The joint venture (SBI has a 74 per cent stake, and the balance is with Hitachi Payment Services) will facilitate expansion of the digital payments landscape in India via its digital payments platform. This will offer innovative products to suit the requirements of all segments of merchants by leveraging the brand value and vast distribution network of SBI, and bring Artificial Intelligence and other technological capabilities of Hitachi to SBI Payment Services, SBI said in a statement.

# RBI imposes Rs 11 crore fine on 4 banks for delayed implementation of Swift operations

The RBI has imposed a total monetary fine of Rs 11 crore on four banks – Karnataka Bank, United Bank of India, IOB and Karur Vysya Bank – for non-compliance of directions on Swift messaging software.

While the RBI imposed a Rs 4 crore penalty on Karnataka Bank, it slapped a fine of Rs 3 crore each on United Bank and Indian Overseas Bank. Besides, the regulator has also levied Rs one crore fine on Karur Vysya Bank.

The Reserve Bank of India has levied an aggregate penalty of Rs 40 million on the bank for delayed implementation of four of the Swift related operational controls, Karnataka Bank said in a regulatory filing.

#### United Bank, HDFC Life sign bancassurance deal

United Bank of India has signed a bancassurance deal with private life insurer HDFC Life Insurance Company. Through this partnership, United Bank's customers will be able to take advantage of HDFC Life's expertise in life insurance products, distribution and customer service.

#### White label ATM operators allowed to source cash directly from RBI

The Reserve Bank relaxed norms for white label ATM (WLA) operators and allowed them to buy wholesale cash directly from the central bank. The RBI also permitted WLA operators to source cash from any bank, including cooperatives and regional rural banks.

# Centre, ADB sign 26 million dollar loan pact for improving drainage infrastructure in Dibrugarh

The Centre and the Asian Development Bank (ADB) have signed a 26 million dollar loan agreement to provide additional financing for improving drainage infrastructure in Dibrugarh town of Assam.

The ongoing loan of 51 million dollars under the Assam Urban Infrastructure Investment Program is helping to improve water supply infrastructure in Guwahati and solid waste management and drainage infrastructure in Guwahati and Dibrugarh.

# IDBI Bank plans three-year extension for current CEO Rakesh Sharma

IDBI Bank on Sunday said it is considering to appoint Rakesh Sharma, the current chief of the bank, as its managing director and chief executive officer for a further period of three years. Sharma's six-month term at IDBI Bank was set to end in April.

# World Bank Signs Agreement to Provide Additional Funding of \$137 million to Enhance Dam Safety in India

The World Bank, Government of India and representatives of 5 state governments of India and implementing agencies signed the loan agreement for additional financing of \$137 million for the Dam Rehabilitation and Improvement Project (DRIP) that will help rehabilitate and modernize over 220

selected large dams in the states of Karnataka, Kerala, Madhya Pradesh, Odisha, Tamil Nadu and Uttarakhand.

# World Bank to provide 250 Million dollar for NRETP to boost Rural incomes in India

World Bank to provide 250 Million dollar for the National Rural Economic Transformation Project (NRETP) to boost Rural Incomes across 13 States in India.

The Agreement was signed by Mr. Sameer Kumar Khare, Additional Secretary, Department of Economic Affairs, Ministry of Finance, on behalf of the Government of India and Mr. Hisham Abdo, Acting Country Director, World Bank India, in New Delhi.

### World Bank to help Sri Lankan farmers tackle climate change

The World Bank approved a \$125 million loan for Sri Lanka to help small farmers improve productivity and tackle climate change. The programme will benefit more than 470,000 small farmers in six provinces in the dry zone of the country, selected for being most exposed to climate impacts.

# RBI slaps penalties on 36 major banks for non-compliance in SWIFT operations

The Reserve Bank on Friday said it has imposed penalties worth Rs71 crore on 36 public, private and foreign banks for non-compliance with various directions on time-bound implementation and strengthening of SWIFT operations.

SWIFT is a global messaging software used for transactions by financial entities. The massive Rs14,000-crore fraud at the PNB was a case of misuse of this messaging software. The banks include, Bank of Baroda, City Union Bank, HSBC, ICICI Bank, SBI and YES Bank.

The penalties, ranging from Rs1 crore to Rs4 crore, were imposed by orders dated 31 January, 2019, and 25 February, 2019,

# HDFC Bank Becomes 3rd Indian Firm To Cross Rs6 trillion Market Cap

India's most valued lender HDFC Bank Ltd crossed the Rs6 trillion market capitalisation for the first time, making it only the country's third firm to achieve the milestone.

Intra-day, the stock touched a fresh record high of Rs2,233 on the BSE, up 2.87% from its previous close. The scrip closed at Rs2,226.10 on the BSE, up 2.56%, with a market capitalisation of Rs6.06 trillion. The Sensex rose 0.58% to end at 37,752.17 points.

HDFC Bank's stock gained for the fifth session in a row, rising as much as 6% during the period. Year-to-date, it has advanced 5%.

#### SEBI lifts foreign investment cap in corporate bonds

Markets regulator SEBI withdrew the 20 per cent limit on investments by Foreign Portfolio Investors in corporate bonds of an entity. In a notification, the regulator said the restriction is being withdrawn in accordance with a circular issued by the Reserve Bank of India (RBI).

In June last year, the Securities and Exchange Board of India (SEBI) had mandated that no Foreign Portfolio Investors (FPIs) shall have an exposure of more than 20 per cent of its corporate bond portfolio to a single corporate.

# **Internet of Things India Congress 2019 to be held in Bengaluru on August 22-23, 2019**

The IoT India Congress 2019 will include tracks on segments such as healthcare, manufacturing, telecom, smart cities, energy, retail, cyber security, skills and development, IoT Standards, legal and regulatory, and agriculture. The Institution of Engineering and Technology (IET) IoT Panel held a conference to announce the upcoming 4th edition of the IoT India Congress.

## Delhi: High-level committee set up to reform higher education

The Delhi government's Dialogue and Development Commission (DDC), a think-tank that advises the government on key issues, has set up a 17-member high-level committee to "reform higher education" in the capital. The committee, chaired by DDC vice-chairperson Jasmine Shah, will "recommend goals, metrics,

policies, and actionable plans for reforming Delhi's higher education system within a year".

#### RBI to take steps to infuse liquidity

In a move to infuse liquidity into the market, the Reserve Bank of India (RBI) said it will conduct a three-year buy-sell swap for the rupee through an auction process. RBI will buy \$5 billion on 26 March for a period of three years and reverse it through sales at pre-determined rates fixed via auction.

Authorised dealers are allowed to participate in the auction . In the first leg of the transaction, the central bank will buy dollars in the spot market from them in exchange for rupees.

#### RBI re-categorizes IDBI Bank as a Private Sector Bank

LIC acquire 51% of the total paid-up equity share capital of the bank Reserve Bank of India has categorized IDBI Bank as a 'Private Sector Bank' for regulatory purposes by with effect from 21 January 2019.

The move is consequent upon Life Insurance Corporation of India acquiring 51% of the total paid-up equity share capital of the bank.

#### RBI relaxes norms for trade credit

The Reserve Bank of India (RBI) relaxed norms for imports of capital and non-capital goods by raising the trade credit limit to \$150 million under the automatic route.

Announcing the modified revised framework for 'Trade Credit Policy', the RBI, however, reduced the all-inclusive cost (all-in-cost) for overseas loans to benchmark rate plus 250 basis points from the earlier 350 bps. Trade credits (TCs) refer to the credits extended by the overseas supplier, bank, financial institution and other permitted recognised lenders for maturity for imports of capital and non-capital goods permissible.

According to the revised framework, TCs up to \$150 million or equivalent per import transaction for oil and gas refining & marketing, airline and shipping companies can be availed under the automatic route.

#### RBI issues guidelines to prevent market abuse

The Reserve Bank of India has come out with guidelines to prevent misuse of price-sensitive information by participants in markets for financial instruments. The RBI said market participants, either acting independently or in collusion, shall not undertake any action with the intention to manipulate the calculation of a benchmark rate or a reference rate. The guidelines have become effective from yesterday.

About regulatory action on market abuse, the RBI said market participants who are indulging in any such activity are liable to be denied access to markets in one or more instruments for a period that may not exceed one month at a time.

# India's trade deficit narrows; exports up by 2.44%, imports decline by 5.4%

India's trade deficit narrowed in the month of February this year to 9.6 billion dollars.

According to data released by the Commerce Ministry, the country's exports grew by 2.44 per cent year-on-year to 26.67 billion dollar while imports declined by 5.4 per cent to 36.26 billion dollars.

The exports grew on account of higher shipments in sectors such as pharmaceuticals, engineering and electronics, the ministry said.

### Got RBI nod for Gruh Finance merger: Bandhan Bank

Bandhan Bank has received "no objection" from the Reserve Bank of India (RBI) for the proposed merger of Gruh Finance with it.

The merger would help the bank to achieve product and geographic diversification while improving penetration in its core customer segment. On the other hand, the housing finance company would get access to a wider distribution network, a larger customer base and low cost deposit base of the bank.

# Aviva Life Insurance launches WINGS program to empower women at workplace

Aviva Life Insurance announced the launch of WINGS, a specially designed mentorship program to empower women workforce. The WINGS program is an

initiative of the SHE division of Aviva Life Insurance for mentoring all the women employees in Aviva. SHE was conceptualised in 2016 by Aviva India's Women Network , an active community of socially enabled women who take up the charge of addressing causes in the interest of women empowerment. The new initiative has been aimed to empower the women in Aviva to fulfil their professional and personal goals.

#### SBI launches cardless ATM withdrawal with YONO Cash

India's largest bank State Bank of India (SBI) announced the launch of YONO Cash using which customers can withdraw money from ATMs without using a card. This feature on YONO is designed to help its users withdraw cash without a physical debit card. it also maximizes convenience and enhances the banking experience for its customers.

YONO will be secured with two-factor authentication and will also eliminate the risk of skimming and cloning.

#### RBI names SBI, ICICI and HDFC as systemically important banks

The Reserve Bank of India (RBI) named State Bank of India (SBI), ICICI Bank and HDFC Bank as Domestic Systemically Important Banks (D-SIBs), which in other words mean banks that are too big to fail.

As per the norms, these banks will have to set aside more capital for their continued operation. RBI comes with the list every year since 2015. Inclusion in D-SIB indicates that failure of any of these banks would have a cascading effect on Indian financial system.

Inclusion in the list gives additional comfort to investors that these banks won't be allowed to fail and therefore, borrowing costs of these banks from the markets are cheaper than their peers.

# ICICI Lombard, MobiKwik join hands to provide cyber-insurance cover of Rs 50,000

The IBBI and the SEBI seek effective implementation of the Insolvency and Bankruptcy Code, 2016 (Code) and its allied rules and regulations, which have redefined the debt-equity relationship and aims to promote entrepreneurship and debt market.

#### The MoU provides for:

- (a) sharing of information between the two parties, subject to the limitations imposed by the applicable laws;
- (b) sharing of resources available with each other to the extent feasible and legally permissible;
- (c) periodic meetings to discuss matters of mutual interest, including regulatory requirements that impact each party's responsibilities, enforcement cases, research and data analysis, information technology and data sharing, or any other matter that the parties believe would be of interest to each other in fulfilling their respective statutory obligations;
- (d) cross-training of staff in order to enhance each party's understanding of the other's mission for effective utilisation of collective resources;

#### 4th CII-EXIM Bank Conclave on India-Africa Project Partnerships Concludes in New Delhi

The 14th CII-EXIM Bank Conclave on India-Africa Project Partnerships concluded in New Delhi . The three-day conclave was organised by the Ministry of Commerce inassociation with Confederation of Indian Industry and EXIM Bank of India.

India's development cooperation ranges from power projects and dams in Sudan and Rwanda to water treatment plants in Tanzania, sugar factories in Ethiopia and IT Parks in Mozambique and Swaziland, building of the Presidential Place in Ghana and National Assembly building in the Gambia, besides other numerous projects.

Dr. AnupWadhawan informed that as part of India's outreach in Africa, Ministry of External Affairs, on 10th September 2018 signed an agreement with the Telecommunications Consultants India Limited (TCIL) to establish a pan-Africa e-Arogya Bharti Network Project to serve as a digital bridge between India and Africa shrinking the distance between India and Africa even more.

#### SBI to auction NPA assets worth Rs 6,169 cr in March

The State Bank of India will auction non-performing assets (NPAs) amounting to Rs 6,169 crore in the next 10 days to recover its dues from various defaulting business outfits.

The country's largest lender carries out auctions of financial assets of those defaulters who have not paid their dues. From March 22-30, the bank, which has already put out a list of the assets, will auction these to asset reconstruction companies (ARCs), banks, non-banking financial companies (NBFCs) and FIs.

# Exim Bank extends \$800 mn credit to Maldives for developmental projects

The Export-Import Bank of India (Exim Bank) said it will provide USD 800 million (about ₹ 5,500 crore) credit to Maldives to finance developmental projects. Exim Bank has extended a Line of Credit (LoC) of USD 800 million to Maldives for financing developmental projects, Exim Bank said in a release.

An agreement for the LoC was signed between Maldives Finance Minister Ibrahim Ameer and Exim Bank Chief General Manager Sudatta Mandal. The LoC agreement was exchanged during the visit of External Affairs Minister Sushma Swaraj to Maldives.

### SBI inks pact with Bank of China

The country's largest lender SBI has signed a pact with the Bank of China to boost business opportunities. SBI has signed a memorandum of understanding (MoU) with Bank of China (BoC), the third-largest bank in the world by capital size and

one of the major players in the Chinese banking sector, to enhance business synergies between both the banks, State Bank of India (SBI) said in a release.

Through this pact, both SBI and BoC will gain direct access to their respective markets of operation, it said. Both banks' clients will be able to use the vast combined network to expand their businesses abroad.

# ADB to Invest \$50 Million in Avaada Energy for Expansion of Solar Projects in India

The Asian Development Bank (ADB) has announced that it will invest \$50 million in Indian renewable energy independent power producer Avaada Energy Private Limited. Avaada aims to use the capital to expand its solar energy generation capacity in India.

The ADB and Avaada entered into an agreement which was signed by the chairman of the company Vineet Mittal and ADB's principal investment specialist Mayank Choudhary.

#### SBI raises Rs 1,251 crore by issuing Basel III-compliant bonds

The country's largest lender State Bank of India (SBI) has raised Rs 1,251.30 crore by issuing Basel III-compliant bonds. "The Committee of Directors for Capital Raising at its meeting held today on 22 March 2019 deliberated and accorded approval to allot 12,513 non-convertible, taxable, perpetual, subordinated, unsecured Basel Ill-compliant additional tier-I bonds, for inclusion in additional tier-I capital of the bank...aggregating to Rs 1,251.30 crore," SBI said in a regulatory filing.

The bonds with a face value of Rs 10 lakh each bears a coupon rate of 9.45 per cent per annum payable annually with call option after 5 years or any anniversary date thereafter.

# Canara Bank issues bonds from London branch to raise up to USD 400 mn

State-owned Canara Bank has launched a bond issuance programme through its London branch to raise up to USD 400 million (about Rs 2,750 crore). The bonds are set to mature on March 28, 2024.

Canara Bank said the bonds are priced at 5-year US Treasury plus 170 basis points carrying a coupon of 3.875 per cent fixed payable half yearly. The bonds will be listed on the Singapore Stock Exchange.

#### Karnataka Bank reports Rs 13.26 crore fraud to RBI

Private sector lender Karnataka Bank has reported a fraud amounting to Rs 13.26 crore in the fund-based working capital facility extended to SRS Finance.

#### RBI's dollar-rupee swap to release Rs 35,000 cr liquidity

The RBI's latest step on the rupee-dollar swap mechanism will unleash Rs 35,000 crore liquidity in the system, while the credit situation is comfortable

Under the new swap arrangement, the RBI plans to buy dollars from banks instead of bonds, but will return these dollars at the end of three years for a forward premium. This premium would be determined through an auction on March 26 .

The RBI will buy \$5 billion from banks for its reserves by giving them rupees, and reverse the trade in 2022. This pre-emptive move would prevent the currency's appreciation, say a section of experts.

### RBI appoints five-member committee to deepen digital payments

Reserve Bank of India (RBI) Governor Shaktikanta Das has said that the central bank of the country has appointed 5-member committee under the chairmanship of Nandan Nilekani to further deepen digital payments and enhance financial inclusion through Fintech. He said, the RBI has requested the committee to give recommendations in 3 months in this regard.

The objective of the conclave is to shape India's continued ascendancy in FinTech, build the narrative for future strategy and policy efforts, and to deliberate steps for comprehensive financial inclusion.

#### RBI slaps Rs 2 crore penalty on PNB

The Reserve Bank of India has slapped a penalty of Rs 2 crore on Punjab National Bank for non-compliance of regulatory directions with regard to SWIFT operations.

SWIFT is a global messaging software used for sharing information on inter-bank transactions by financial entities.

#### Axis Bank opens 4,000th branch

Private sector lender Axis Bank opened its 4,000th branch at EON, Kharadi, in Pune. The new branch was inaugurated by Amitabh Chaudhry, Managing Director and CEO, Axis Bank, and Ravi Narayanan, President and Head Branch Banking, Axis Bank.

"The initiative is in line with the government's vision of providing banking services within 5 km for every Indian citizen. The bank has added 297 branches in the current fiscal across India," the lender said in a statement.

#### Govt decides to infuse around Rs 5000 Cr into Bank Of Baroda

The government has decided to infuse around five thousand crore rupees into state-owned Bank of Baroda ahead of merger of two other public sector lenders Dena Bank and Vijaya Bank with Bank of Baroda. The merger of Dena Bank and Vijaya Bank with Bank of Baroda would be effective from 1st April.

The Bank of Baroda, in a regulatory filing, said that the finance ministry through its notification conveyed its decision to infuse capital of 5,042 crore rupees in the bank.

## BoB set to develop digital agri platform for farmers

Bank of Baroda has signed a memorandum of understanding with agriculture services companies to develop an agriculture digital platform, Baroda Kisan, which will provide solutions for agricultural requirements.

The initiative is being executed by ITCoE of Bank of Baroda, in partnership with IBM India. The platform intends to make a holistic approach towards solving agricultural plights by means of providing reliable and customised information,

inputs for use, convenience of renting farm equipment, and market linkage for sale of agriculture produce.

# India Inc's foreign borrowings fall 9% to \$2.81 bn in February; Oil India emerges as top borrower

**India Inc's borrowings from foreign markets fell to USD 2.81 billion** in February, down by 9 per cent as compared to the year-ago month, data from the Reserve Bank of India showed.

The domestic firms had raised as much as \$3.1 billion through the external commercial borrowing (ECB) route in the corresponding month of 2018. No firms tapped the rupee-denominated bonds route to borrow capital from foreign markets during February.

Among the major borrowers were Oil India Ltd (USD 550 million for overseas investment), Indian Oil Corporation (USD 400 million as working capital loan), Shriram Transport Finance Company (USD 400 million for sub-lending) and Mahindra & Mahindra Financial Services (USD 300 million for sub-lending).

#### RBI clears Rs19,240 crore CCL for Punjab for Rabi marketing season

The Reserve Bank of India (RBI) cleared Rs 19,240.91 crore towards Cash Credit Limit (CCL) for Punjab for the purchase of wheat in the Rabi marketing season. With this, the bulk of the CCL sought by the state government for the purchase of 130 lakh tonne of wheat for this season has been released by the central bank.

The release of the CCL would facilitate the state government in making timely payments to farmers against purchases of food grains in the current season, which would begin from April 1 and culminate on May 25, it said.

# India's forex reserves rise for 3rd week in a row, now at \$407 billion:

India's foreign exchange (forex) reserves continued to surge for a third week, adding \$1.029 billion to \$406.667 billion in the week to 22 March, according to data from the Reserve Bank of India (RBI). Forex reserves had increased by \$3.6 billion to \$405.6 billion in the previous reporting week driven by an increase in foreign currency assets.

Gold reserves were unchanged at \$23.408 billion in the reporting week, according to data from the central bank. The special drawing rights with the International Monetary Fund (IMF) dipped by \$0.7 million to \$1.460 billion.

#### Sebi exempts govt from PNB open offer to bring its stake below 75%

The Securities and Exchange Board of India (Sebi) has exempted the government from making an open offer for the shareholders of **Punjab**National Bank (PNB) but directed reduction in non-public shareholding in the lender post capital infusion.

After capital infusion in lieu of preferential allotment of over 80.2 crore shares, the government's stake in the bank would rise **by 5.19% to 75.41%.** 

#### **RBI** raises FPI investment limit in G-Secs

The Reserve Bank of India upped the investment limit for FY2019-20 for foreign portfolio investors (FPI) in **Central government securities (G-Secs) to 6 per cent** of outstanding stock of securities from 5.5 per cent in FY2018-19. The limit for FPI investment in **State development loans (SDLs) and corporate bonds** has been left unchanged at **2 per cent and 9 per cent of outstanding stocks.** 

As against the current limit of ₹6,49,900 crore, the revised limit for FPI investment in debt for FY2020 has been set at ₹6,98,300 crore for the first half, and ₹7,46,500 crore for the second half of the financial year.

### Govt leaves interest rate on small-saving schemes unchanged

The Finance Ministry has decided to keep **the interest rate unchanged on small savings schemes for the three-month period beginning April 1.** The announcement covers small-saving schemes such as the Post Office Saving Accounts, Post Office Time Deposits, the National Saving Certificates (NSC), the Public Provident Fund (PPF), the Kisan Vikas Patra (KVP) and Sukanya Samriddhi.

The unchanged interest rate means the NSC (5 years) and the PPF (15 years) will fetch **8 per cent interest**, while money deposited in KVP will double in little over nine years . At the same time, if one is parking money in a fixed deposit with a maturity of five years with the State Bank of India, he/she will get 6.85 per cent. **Senior citizens will get half a per cent more: 7.35 per cent.** 

#### India's April-February fiscal deficit at 134% of FY target: Govt data

The country's fiscal deficit touched 134.2 per cent of the full-year revised budgeted estimate at the end of February 2019, mainly due to tepid growth in revenue collections.

In absolute terms, the fiscal deficit for April-February 2018-19 was Rs 8.51 lakh crore as against the revised estimate (RE) of Rs 6.34 trillion for the entire year, according to Controller General of Accounts (CGA) data.

#### RBI sets NBFC-MFIs' average base rate at 9.21% for Apr-Jun

The Reserve Bank set the average base rate to be charged from borrowers by non-banking financial companies (NBFCs) and micro-finance institutions (MFIs) at 9.21 per cent for the first quarter of the next fiscal.

The applicable average base rate to be charged by Non-Banking Financial Company Micro Finance Institutions (NBFC-MFIs) to their borrowers for the quarter beginning April 01, 2019 will be 9.21 per cent, the RBI said in a notification.

# BNP Paribas Cardif sells 5 crore shares in SBI Life Insurance for Rs 2,889 crore

BNP Paribas Cardif sold 5 crore shares of SBI Life Insurance through a block deal for Rs 2,889 crore, which saw shares skidding over 6 per cent on the local bourses. SBI Life Insurance is a joint venture life insurance company between State Bank of India, the country's largest bank, and French multinational bank BNP Paribas Cardif.

BNP Paribas sold its stake in the company through the open market at average price of Rs 577.93 per equity share.

## Infosys arm to buy 75% stake in Dutch bank subsidiary

Global software major Infosys said its consulting arm would buy 75 per cent equity stake in Starter N.V., a subsidiary of the Dutch-based ABN AMRO Bank for Rs 999 crore (\$144 million) in cash for strategic partnership in The Netherlands.

The Amsterdam headquartered third largest Dutch bank ABN will hold the remaining 25 per cent of the shareholding in Stater.

#### Vijaya Bank, Dena Bank to merge with Bank of Baroda

In a first three-way amalgamation, Vijaya Bank and Dena Bank will merge with Bank of Baroda from tomorrow to create the third-largest lender of the country.

The Reserve Bank of India had said in a statement that customers including depositors of Vijaya Bank and Dena Bank will be treated as customers of Bank of Baroda with effect from 1st April this year.

#### PNB Sells 13.01% Stake In Housing Finance Arm for Rs1851.60 crore

State-owned lender Punjab National Bank (PNB) had sold stake in its housing finance arm, PNB Housing Finance (PNBHF) to General Atlantic Group and Varde Partners for Rs 1,851 crore at Rs 850 per share. Both VardePartners and General Atlantic Group will buy 1.089 crore shares each at Rs 850 per share in the housing finance company from Punjab National Bank.

After the transaction, Punjab National Bank will continue to hold a strategic stake of 19.78% in the housing finance company and will remain the promoter and strategic shareholder of the company, the lender informed the stock exchanges.

#### **AYUSH Minister lays foundation stone for National Institute of Unani Medicine**

AYUSH Minister Shripad Yesso Naik laid the foundation stone for National Institute of Unani Medicine at Ghaziabad in Uttar Pradesh.

Addressing the ceremony, Mr Naik informed that his Ministry is establishing the Institute in Ghaziabad as a part of its commitment towards provision and promotion of quality education, research and healthcare services through Unani Medicine and other AYUSH systems. this institute would be developed with an approximate cost of 300 crore rupees on 10 acres of land. It would be one of the largest institutes of Unani Medicine in Northern India.

#### **Cabinet approves National Policy on Software Products – 2019**

Union Cabinet, chaired by the Prime Minister Shri Narendra Modi has approved the National Policy on Software Products – 2019 to develop India as a Software Product Nation.

The Software product ecosystem is characterized by innovations, Intellectual Property (IP) creation and large value addition increase in productivity, which has the potential to significantly boost revenues and exports in the sector, create substantive employment and entrepreneurial opportunities in emerging technologies and leverage opportunities available under the Digital India Programme, thus, leading to a boost in inclusive and sustainable growth.

Initially, an outlay of Rs.1500 Crore is involved to implement the programmes/schemes envisaged under this policy over the period of 7 years. Rs1500 Crore is divided into Software Product Development Fund (SPDF) and Research & Innovation fund.

#### **Cabinet approves Kanpur Metro Rail Project**

The Union Cabinet meeting, chaired by the Prime Minister Narendra Modi has approved Kanpur Metro Rail Project having two corridors, which will connect major public nodes and city cluster areas of Kanpur. Implementation of Metro Rail System will result in less vehicular traffic and better movement on the roads leading to reduction in congestion, travel time, cost of journey and pollution.

# India's GDP growth slows down to 6.6% in December quarter, fails to meet expectations

India's GDP growth has slowed down to 6.6 per cent in the December quarter, as per the latest government data. The growth rate is below expectations. A Reuters poll had anticipated a GDP growth of 6.9 per cent.

India's Gross Domestic Product (GDP) growth was revised down to 7 per cent from 7.1 per cent in the second quarter ended September 30, 2018, according to data released by the Ministry of Statistics and Programme Implementation. The growth in GDP during 2018-19 is estimated at 7 per cent as compared to the growth rate of 7.2 per cent in 2017-18, the Ministry of Statistics said. Last month, the Central Statistics Office (CSO) has projected Indian economy to grow at 7.2 per cent for this fiscal under its first advance estimates.

#### Indian economy expected to grow at 7.3% in 2019-20: Moody's

Indian economy is expected to grow at 7.3 per cent in calendar years 2019 and 2020, the US-based rating agency Moody's said.

The agency said the country is less exposed to a slowdown in global manufacturing trade growth than other major Asian economies and emerging markets and is poised to grow at a relatively stable pace in the two years.

Moody's said the announcement in Interim Budget 2019-20 on direct cash transfer programme for farmers and the middle-class tax relief measures will contribute a fiscal stimulus of about 0.45 per cent of GDP.

#### GST collection in February stands at Rs 97,247 cr

The GST collection in the month of February stood at 97 thousand 247 crore rupees. However, the collection in previous month was over one lakh crore rupees. the total number of GSTR 3B returns filed for the month of January up to 28th February is over 73 lakh.

The DotBook is expected to create a positive impact for the visually impaired community as independent digital access has become a vital part of day-to-day living.

According to the latest data compiled in the IQ Air Visual 2018 World Air Quality Report and interactive world's most polluted cities ranking, which is prepared in collaboration with Greenpeace Southeast Asia in order to reveal the state of particulate matter (PM2.5) pollution in 2018, Delhi had an average yearly PM2.5 concentration at 113.5 micrograms per cubic metre.

#### India to get first jewellery park set on 21 acres at Navi Mumbai

# Amendment in Hazardous Waste (Management& Transboundary Movement) Rules, 2016

In order to strengthen the implementation of environmentally sound management of hazardous waste in the country, the Ministry of Environment, Forest and Climate Change has amended the Hazardous and Other Wastes (Management & Transboundary Movement) Rules, 2016.

The amendment has been done keeping into consideration the "Ease of Doing Business" and boosting "Make in India" initiative by simplifying the procedures under the Rules.

Some of the salient features of the Hazardous and Other Wastes (Management& Transboundary Movement) Amendment Rules, 2019 are as follows:

- Solid plastic waste has been prohibited from import into the country including in Special Economic Zones (SEZ) and by Export Oriented Units (EOU).
- Exporters of silk waste have now been given exemption from requiring permission from the Ministry of Environment, Forest and Climate Change.
- Electrical and electronic assemblies and components manufactured in and exported from India, if found defective can now be imported back into the country, within a year of export, without obtaining permission from the Ministry of Environment, Forest and Climate Change.
- Industries which do not require consent under Water (Prevention and Control of Pollution) Act 1974 and Air (Prevention and Control of Pollution) Act 1981, are now exempted from requiring authorization also under the Hazardous and Other Wastes (Management & Transboundary Movement) Rules, 2016.

## PM releases new series of visually impaired friendly coins

The Prime Minister, Shri Narendra Modi released the new series of visually impaired friendly circulation coins,in New Delhi.Rs.1, Rs.2, Rs.5, Rs.10 and Rs.20 are the various denominations of coins released as part of the new series.

The new circulation coins with various differentiating features, will greatly aid the visually impaired. The new series of coins will facilitate the visually impaired, and will instil them with confidence.

The coins are characterized by the increasing size and weight from lower to higher denominations. The newly included coin of Rs.20, will be a 12 sided coin with no serrations. The rest of the denominations would be of round shape.

#### **Cabinet approves Continuation of Atal Innovation Mission**

The Union Cabinet chaired by the Prime Minister Shri Narendra Modi has approved Continuation of Atal Innovation Mission (AIM), and for incurring expenditure up to Rs. 1000 crore till 2019-20 by Atal Innovation Mission for expanding Atal Tinkering Labs to 10,000 schools in view of their huge success at school level.

#### **Details:**

- AIM has multiple programs to encourage and support innovation in the country.
- State of the art Atal Tinkering Labs (ATLs) are being established in thousands of schools, world class Atal Incubation Centres (AIC) and Atal Community Innovation Centers (ACIC) are being established for universities and industry,
- Promotion of product development in areas of national relevance and social importance is being supported through Atal New India Challenges (ANICs).

#### **Financial implications:**

- Each ATL receives a grant in aid of Rs. 12 lakhs in the first year, and upto 2 lakhs per year for subsequent 4 years, for maintenance of the ATL equipment and operational expenses.
- Each selected AIC would be receiving grant in aid upto Rs 10 crore over 3-5 years in tranches per year, based on review and evidence of planned milestones reached.
- Innovators will receive commercialization and technology deployment grants upto Rs. 1 crore under the ANICs.

### Cabinet approves Scheme to Rebate State and Central Embedded Taxes to Support the Textile Sector

The Union Cabinet chaired by Prime Minister Narendra Modi has approved the Scheme to Rebate State and Central Embedded Taxes to Support the Textile Sector. This will enable the Government to take various measures for making exports of apparel and made-ups zero rated.

#### **Details:**

At present, apparel and made-ups segments are supported under the Scheme for Rebate of State Levies (RoSL). However, certain State as well as Central Taxes continued to be present in the cost of exports. The Cabinet decision provides for a scheme to rebate all embedded State and Central Taxes/levies for apparel and made-ups which have a combined share of around 56% in India's textile export basket. Rebate of taxes/levies has been permitted through an IT-driven scrip system at notified rates.

# **Cabinet approves continuation of National AIDS Control Programme- IV (NACP-IV)**

The Cabinet Committee on Economic Affairs chaired by the Prime Minister has given its approval for continuation of National AIDS Control Programme-IV (NACP-IV) beyond 12th Five Year Plan for a period of three years from April, 2017 to March, 2020. The total outlay will be Rs.6434.76 crore.

#### **Benefits:**

- More than 99% of population will be kept HIV free.
- More than 70 lakh of key population covered annually through a comprehensive HIV prevention programme.
- Around 15 crore of vulnerable population (including five crore pregnant women) will be tested for HIV in three years of project.
- Two crore 32 lakh units of blood will be collected at NACO's supported blood banks during three year of project.
- Two crore 82 lakh episodes of sexually transmitted infections will be managed under project during three years of project.
- Seventeen lakh of PLHIV will be put on free anti-retroviral treatment by end of project period.

# NGT imposes Rs 500 cr fine on Volkswagen for cheating emission tests

The National Green Tribunal slapped a fine of 500 Crore rupees on German auto major Volkswagen for damaging the environment using cheat device in its diesel cars in India. A bench headed by NGT chairperson Justice Adarsh Kumar Goel directed the carmaker to deposit the amount within two months.

CCEA approves investment approval for 1320 megawatt Khurja Super Thermal Power Plant in Bulandshahar

The Cabinet Committee on Economic Affairs, CCEA has approved the investment approval for a 1320 megawatt Khurja Super Thermal Power Plant (STPP) in Bulandshahar of Uttar Pradesh.

Eleven thousand eight nine crore rupees will be spent on the plant. Investment approval for 1320 Mega Watt Buxar thermal Power Project in District Buxar of Bihar was also approved.

The project will be completed at an estimated cost of ten thousand 439 crore rupees. The Buxar Thermal Power Project will improve the deficit power scenario in Bihar and Eastern Region. It will start yielding benefit from 2023-24.

The CCEA also approved Amelia Coal Mine in Singraulli, Madhya Pradesh. Cabinet has also approved Delhi Metro Phase -4 Project.

# National Centre for Good Governance inks pact with Indian Institute of Corporate Affairs

A Memorandum of Understanding, MoU, was signed between the National Centre for Good Governance (NCGG) and the Indian Institute of Corporate Affairs (IICA) to ensure better utilisation of infrastructure facilities during training programmes.

IICA will support the good governance centre for utilization of infrastructure facilities during training programme of NCGG at Delhi, and for academic and intellectual interactions for five years.

The NCGG has been set up by the government of India under the aegis of DARPG. It aims to promote good governance through capacity building on public policy and governance both at national and international level and carrying out studies research on issues relating to governance.

"Aadhaar authentication services shall be charged at the rate of Rs. 20 (including taxes) for each e-KYC transaction and Rs. 0.50 (including taxes) for each Yes and No authentication transaction from requesting entities," a notification by the UIDAI said.

# UP, Bihar fall behind in human development index as Rajasthan, UP improve

Uttar Pradesh and Bihar did poorly on the human development index (HDI), as smaller states Haryana and Himachal improved in the last 27 years. Industrial Gujarat and Maharashtra slipped in the HDI ranking between 1990 and 2017, while Haryana has improved the most, finds SBI Research in a report that is based on the data from Subnational HDI for the states.

Southern states continue to lead the pack on the crucial measure, where the country is ranked 130th globally, but are staring at a different trouble, the report noted.

### IGIA declared as 'Best Airport' in 2018 ASQ Awards

The Indira Gandhi International (IGI) airport here has been adjudged as the best airport in the category of over 40 million passengers per annum (MPPA) in Asia Pacific by Airports Council International (ACI) in the Airport Service Quality Programme for 2018.

This award is a testimony of continued improvements in passenger-service that Delhi Airport has witnessed since DIAL took over its operations in 2006.

In 2011, the Airport had achieved the position of World No. 2, which it retained for three consecutive years till 2013. In 2014, it stepped up its position to World 1 rank in the 25-40 MPPA category and retained the rank in 2015.

The Housing and Urban Affairs Ministry said in a statement that the project will be implemented by the Gujarat Metro Rail Corporation and it will be completed in five years.

Over the past years, Barbie, the fashion doll manufactured by the American toy company Mattel, has seen many avatars. The doll brand, which was launched in 1959, has transformed from featuring "pretty" dolls to Barbie being a surgeon, a news anchor, an astronaut and a president among other roles.

### IIT-Kharagpur team creates app to detect fake currency notes

A team of IIT-Kharagpur students has developed the code for a smartphone app that can detect counterfeit currency. The team leader explained that the app verifies a note's authenticity, uploaded by a user, using 25 features extracted from the front and rear side of it. In the case of fake note detection, the user is also notified of failure checkpoints.

The Election Commission (EC) has formed a three-member committee to assess the situation on the ground in Jammu and Kashmir before it takes a decision about holding the Assembly elections in the troubled state.

Chief Election Commissioner (CEC) Sunil Arora said, the three members of the committee are two retired IAS officers Noor Mohammed and Vinod Zutshi and a retired IPS officer, A.S. Gill.

### Airtel to transfer 32% stake in Bharti Infratel to Nettle

Bharti Airtel Ltd will transfer as much as 32% stake it owns in tower company Bharti Infratel Ltd to wholly owned unit Nettle Infrastructure Investments Ltd to explore opportunities to monetize the asset, the telecom operator said on Tuesday.

Airtel and Nettle own 50.33% and 3.18%, respectively, in Bharti Infratel now. After the transfer of stake, which is scheduled to be completed on or after 18 March, Airtel and Nettle will own 18.33% and 35.18%, respectively.

### Digital media powered growth in India's M&E industry in 2018: Report

India's media and entertainment (M&E) sector grew 13.4% year-on-year to touch Rs1.67 trillion in 2018, powered by digital platforms that grew 42% to Rs16,900 crore during the period. The M&E sector in India is expected to cross Rs2.35 trillion (\$33.6 billion) by 2021, at a compounded annual growth rate of 11.6%, according to the report by lobby group Federation of Indian Chambers of Commerce and Industry (Ficci) and consulting firm EY.

# National Company Law Appellate Tribunal reserves its order on petition by Reliance Communications

The National Company Law Appellate Tribunal has reserved its order on a petition by Reliance Communications which has approached the tribunal seeking the release of income tax refunds to clear dues of Ericsson.

Lenders of RCom opposed the plea, saying that it will lead to outgo of public money for settling payment of a private party. After hearing both the sides yesterday, the Tribunal bench headed by Chairperson S J Mukhopadhaya reserved the order in the case.

# United States to set up six nuclear power plants in India

India and the United States have committed to strengthen bilateral security and civil nuclear cooperation, including the establishment of six US nuclear power plants in India.US reaffirmed its strong support of India's early membership in the Nuclear Suppliers Group. This commitment was made at the 9th round of the India-US Strategic Security Dialogue held in Washington DC yesterday.

### RBI to infuse Rs 12,500 crore via OMOs

The Reserve Bank of India will infuse 12,500 crore rupees into the system through open market operations (OMOs). The purchase will happen through multi-security auction using the multiple price method. OMOs are money market tools to infuse or suck out liquidity from the system.

### **Industrial growth slows to 1.7% in January 2019**

Industrial output growth stood at 1.7 per cent in January this year on account of slowdown in the manufacturing sector.

According to the Ministry of Statistics and Programme Implementation data, factory output as measured in terms of the Index of Industrial Production (IIP) had grown by 7.5 per cent in January last year.

During April-January 2018-19, industrial output grew at 4.4 per cent as against 4.1 per cent in the same period previous fiscal.

### Arecanut gets 'Sirsi supari' geographical indication tag

Arecanut (also known as supari or betel nut) is the latest entrant in the list of agricultural produce with a GI (geographical indication) tag. the Registrar of Geographical Indications, Government of India, accorded a GI tag, 'Sirsi Supari', to arecanut grown in Sirsi, Siddpaur and Yellapur taluks of Uttara Kannada district in Karnataka.

## India one of world's fastest-growing large economies: IMF

This was stated by IMF communications director Gerry Rice while responding to a question on India's economic development in the last five years at a fortnightly news conference yesterday night in Washington.

### Fitch cuts India's GDP growth forecast for FY20 to 6.8%

Fitch Ratings cut India's economic growth forecast for the next financial year starting April 1, to 6.8 per cent from its previous estimate of 7 per cent, on weaker than expected momentum in the economy.

"While we have cut our growth forecasts for the next fiscal year (FY20, ending in March 2020) on weaker-than-expected momentum, we still see Indian GDP growth to hold up reasonably well, at 6.8 per cent, followed by 7.1 per cent in FY21," Fitch said in its Global Economic Outlook.

The Lalit Kala Akademi (LKA) announced 15 winners of the 60th Annual Academy Awards .

All the awardees will be honoured with a plaque, a shawl and prize money of Rs 1 lakh at the 60th National Exhibition of Art, scheduled from March 25 to April 8 at the National Gallery of Modern Art (NGMA) and Sir JJ School of Art. The winners will also display their artworks at the exhibition. This year, the Akademi received over 6,100 entries by 2,836 artists. The figures almost doubled from last year's 1,433 applicant artists.

The 60th National Exhibition of Art this year will exhibit artistic brilliance and provide a platform to give appreciation and recognition to outstanding artists on a nationwide scale, LKA said.

# **India cut 84% TB deaths in AIDS patients by 2017**

India achieved 84 per cent reduction in tuberculosis deaths among people living with HIV by 2017 – three years ahead of the target, said a report by The Joint United Nations Programme on HIV/AIDS (UNAIDS).

The report showed that India is among the five low or middle-income countries Eritrea (83 per cent), Djibouti (78 per cent), Malawi (78 per cent) and Togo (75 per cent), that achieved or exceeded the target of a 75 per cent reduction in TB deaths among people living with human immunodeficiency virus (HIV), by 2017, three years ahead of the 2020 target.

# Asian Rich List 2019: Hinduja family tops with net worth of £25.2 billion

Leading London-based NRI industrial tycoons, the Hinduja family top the Asian Rich List 2019 for the sixth successive year with an estimated net worth of £25.2 billion, an increase of over £3 billion over the previous year. According to the Asian Rich List 2019 released at the Asian Business Awards , Steel magnates Lakshmi Mittal and his son Aditya Mittal remained in second place, with £11.2 billion — down £2.8 billion.

India's High Commissioner to the UK Ruchi Ghanashyam released the list which is a compilation of the 101 wealthiest Asians in Britain, highlighting exceptional entrepreneurial achievement over the last 12 months.

S P Lohia (Petrochemicals) took the third place with £5.8 billion.

"India became the world's third-largest aviation market in terms of passenger throughput, behind the US and China, in 2018.

The ACI's World Airport Traffic Forecasts also predicts the country will represent

the third largest aviation market in terms of passenger throughput after the US and China by 2020.

The financially-struggling airline also announced the constitution of an Interim Management Committee "at the instructions of the lenders to manage and monitor the daily operations and cashflow of the company".

These rules will apply to all new drugs, investigational new drugs for human use, clinical trial, bioequivalence study and Ethics Committee. It has reduced the time for approving applications to 30 days for drugs manufactured in India and 90 days for those developed outside the country.

The rules stated that in case of no communication from Drugs Controller General of India, the application will be deemed to have been approved.

### Navy's nuclear, biological, chemical training facility launched

Chief of Naval Staff Admiral Sunil Lanba inaugurated the Indian Navy's Nuclear, Biological and Chemical Training Facility (NBCTF) at INS Shivaji in Lonavala. The NBCTF, christened "Abhedya", impenetrable in Sanskrit, will help train personnel of naval ships fitted with nuclear, biological and chemical detection and protection systems.

Admiral Lanba launched the INS Shivaji's website on the Indian Navy portal. He also released the platinum jubilee logo, with the theme "Propelling the Indian Navy since 1945", for the premier technical training establishment.

# IAF inducts first four heavy-lift Chinook helicopters

Indian Air Force (IAF) formally inducted the four heavy-lift Chinook helicopters. Air Chief Marshal BS Dhanoa announced the induction at a ceremony held at Air Force base in Chandigarh. Chinook helicopters will be deployed at Chandigarh's Air Force Station 12 Wing.

these helicopters are capable of vertical lift and heavy lifting in hilly areas. He said that vertical lift capability across a diversified terrain was required as India faces multiple security challenges.

The Chinook helicopter has fully integrated digital cockpit management system and is capable of transporting fully-equipped infantry soldiers for specialised operations.

### India, China, US see 70% rise in energy demand: IEA

China, the US and India together accounted for nearly 70 per cent of the rise in energy demand, even as such demand worldwide grew by 2.3 per cent last year, at its fastest pace this decade, the International Energy Agency (IEA) said.

This exceptional rise in energy demand was driven by a robust global economy and stronger heating and cooling needs in some regions.

These findings are part of the IEA's latest assessment of global energy consumption and energy-related carbon dioxide (CO<sub>2</sub>) emissions for 2018.

# Cabinet approves acquiring land of Central Water Commission at Nallagandla, Hyderabad by Telangana State Government

The Union Cabinet, chaired by the Prime Minister Shri Narendra Modi, has given its approval for acquiring 372 sq. yards out of 10 acres of land including compound wall (about 200m) in the eastern side of Central Water Commission land by the Telangana State Government for improvement of Radial Road No.30 by widening of road with nil charges.

### Cabinet approves five year's extension of Biomedical Research Career Programme

The Union Cabinet, chaired by the Prime Minister Shri Narendra Modi, has approved the continuation of the Biomedical Research Career Programme (BRCP), and Wellcome Trust (WT) / DBT India Alliance beyond its initial 10-year term (2008-09 to 2018-29) to a new five year phase (2019-20 to 2023-24) with Department of Biotechnology (DBT) increasing its commitment to two times that of WT.

The total financial implication will be Rs. 1092 crore with DBT and WT contributing Rs.728 crore and Rs.364 crore respectively.

# EC appoints special expenditure observers in six states

Election Commission has appointed Special Expenditure Observers for six States in view of the forthcoming elections. These states are Andhra Pradesh, Arunachal Pradesh, Gujarat, Karnataka, Nagaland and Telangana.

The poll body appointed former member of CBDT, Gopal Mukherjee as special expenditure observer for Andhra Pradesh and Telangana while former Director General I-T(Investigation), D D Goel has been deployed in Arunachal Pradesh and Nagaland.

# JCB Literature Prize announces 2019 jury, includes Arvind Subramanian

The JCB Prize for Literature, India's richest literary prize given out annually, announced the jury for its secondA edition. It includes former Chief Economic Adviser Arvind Subramanian.

The five-member 2019 jury comprises author and critic Anjum Hasan, authors K.R. Meera and Parvati Sharma and economist and former Chief Economic Adviser Arvind Subramanian. Filmmaker and environmentalist Pradip Krishen is the jury's Chair, JCB said.

The Rs 25-lakh prize, presented each year to a distinguished work of fiction by an Indian author selected by the jury, aims to create greater visibility for contemporary Indian writing.

# Adani becomes first Indian port operator to record 200 MMT cargo movement

Adani Ports and Special Economic Zone (APSEZ) has recorded cargo movement of more than 200 million metric tonnes (MMT) at nine ports along the east and west coasts, becoming the first Indian port operator to achieve the milestone.

"Our projections were to reach this milestone by 2020 but we could achieve it ahead of schedule, courtesy the tech-driven operational efficiency and enhanced asset utilisation," said APSEZ Chief Executive Officer Karan Adani.

- **Araku Valley Arabica coffee** can be described as coffee from the hilly tracks of Visakhapatnam district of Andhra Pradesh and Odisha region at an elevation of 900-1100 Mt MSL. The coffee produce of Araku, by the tribals, follows an organic approach in which they emphasise management practices involving substantial use of organic manures, green manuring and organic pest management practices.
- **Bababudangiris Arabica** coffee is grown specifically in the birthplace of coffee in India and the region is situated in the central portion of Chikmagalur district. The Ahmedabad-based group has received the approval from the US Food and Drug Administration (USFDA) to market the drug in strengths of 5 mg and 10 mg, Zydus Cadila said in a statement.

The product would be manufactured at the group's formulations manufacturing facility at SEZ, Ahmedabad. The sales of Ambrisentan tablets USP in the US market stood at USD 943 million (about Rs 6,500 crore) last year.

Zydus said it now has 258 approvals from the USFDA and has so far filed over 350 abbreviated new drug applications (ANDAs) since the commencement of its filing process in 2003-04.

# Dhanbad best city for 4G availability in India, Srinagar grabs 3rd spot

In terms of 4G availability, Dhanbad in Jharkhand has topped the list of 50 cities in India, according to London-based wireless coverage mapping company OpenSignal. The next census of India will be carried out in **2021** with March 1 of that year as the reference date, the **Home Ministry** announced In a notification, the ministry said the decision has been taken by the central government under the powers conferred by **section 3 of the Census Act, 1948 (37 of 1948).** For Jammu and Kashmir and snow bound non-synchronous areas of Himachal Pradesh and Uttarakhand, the reference date shall be the **first day of October, 2020**, the notification said.

## Government to borrow Rs 4.42 lakh crore in H1FY20

Announcing the borrowing calendar for the first half of the next financial year (April to September 2019), the Union Ministry of Finance said that the government will borrow Rs 4.42 lakh crore during the period.

Economic Affairs Secretary Subhash Chandra Garg said the government will raise the Rs 4.42 lakh crore through gilts and that borrowing for the second half is set at Rs 2.68 lakh crore. In the current fiscal year set to end on Sunday, borrowing for the whole year is estimated at Rs 5.71 lakh crore.

As per the Union Budget, the government's gross borrowing was pegged at Rs 7.1 lakh crore for 2019-20, which also includes repayments of past loans. Net borrowing was pegged at Rs 3.4 lakh crore in the first half of the next fiscal.

Taking 1st April, 2019 as the zero date, the project is expected to be completed in two years time, i.e, by 31st March, 2021. Thereafter, it will take another 6 months for the Centre to become operational.

It is expected that creation of new benches will enable faster disposal of cases.

# Mizoram Governor Kummanam Rajasekharan resigns

Governor of Mizoram Kummanam Rajasekharan has resigned from his post. President Ram Nath Kovind has accepted the resignation of Rajasekharan.

Mr. Kovind has appointed Prof. Jagdish Mukhi as the Governor of Mizoram, in addition to his own duties of Assam Governor, until regular arrangement for the office of the Governor of Mizoram is made.

# World Bank to give Rs 2,200 cr for Andhra healthcare project

The yojana will be implemented in some areas of the state on a pilot basis and later its scope will be expanded. in the first phase, the target is to cover 20,000 workers and provide them with good quality food at a nominal cost of Rs five.

#### Kerala's Marayur jaggery gets GI tag

Kerala's Marayur jaggery has finally got the geographical indication (GI) tag, making it safe for consumption while rejuvenating the traditional way of production and ensuring a safe market in future.

#### Nagaland launches 1st round polio immunization

Nagaland launched the first round of immunisation as part of the nationwide Pulse Polio programme. One-and-a-half lakh children of less than five years will be given polio drops to sustain polio eradication.

According to the Directorate of Health and Family Welfare, 2,274 polio booths have been set up to administer polio drops to children.

# MP govt issues ordinance to give 27% quota to OBCs

In Madhya Pradesh, the state government has issued an ordinance raising reservation for Other Backward Classes (OBC) to 27 per cent from the present 14 per cent.

# 2 Delhi metro stations renamed in honour of martyrs

Two stations on Delhi Metro's red line extension have been renamed in honour of martyrs. This comes days after Pulwama attack where 40 CRPF jawans were martyred.

The nine-day fest, starting from April 4, is being organised by the City Montessori School (CMS), the world's largest city school as per the Guinness World Records.

### Matildas launch new kit for Women's World Cup

Australian women's national team will wear brand new kit with the words "Never Say Die" printed inside at the upcoming FIFA Women's World Cup, starting on June 7 in France.

The all-new Australia home kit unveiled by Nike is part of a first-ever national team collection designed exclusively for the Australian team, which shows the growing popularity of the top quadrennial event of women's football. The words "Never Say Die", a reference to a common rallying cry among the players, are printed inside the kit.

### **Jharkhand bans e-cigarettes**

The Jharkhand government banned the sale and usage of e-cigarettes in the state, according to an official notification.

"E-cigarettes are the new method of nicotine use. It affects the embryos in pregnant woman. It also causes mental problem. The sale, distribution, advertisement, import and usage of e-cigarettes have been banned with immediate effect," the notification issued by the state's health department said.

# Indian media, entertainment to cross \$33 bn by 2021

The Indian media and entertainment sector revenues reached \$23.9 billion in 2018, and are expected to cross \$33.6 billion by 2021, at a compound annual growth rate (CAGR) of 11.6 per cent, said a study released. The report by the Federation of Indian Chambers of Commerce and Industry (Ficci) and Ernst & Young LLP was launched at the inaugural session of the Ficci Frames 2019.

While television retained its position as the largest segment, growth is expected to come from digital, which is expected to overtake filmed entertainment in 2019 and print by 2021.

In 2018, the media and entertainment sector registered a growth of 13.4 per cent over 2017.

Founded in 2006, Qwikcilver is a full-stack gift card service provider, powering nine out of every 10 gift cards in the country and managing an annualised gross transaction value of \$1.5 billion across India, Middle East and South East Asia.

#### Kerala firm bags contract to build Manipur airport

State-owned KITCO Ltd has bagged the project management consultancy (PMC) contract from Airports Authority of India (AAI) for setting up a new Rs 600 crore integrated terminal building at Imphal International Airport. The deadline for the completion of the project is 54 months.

This is the second PMC contract received from AAI after the Mangalore Airport expansion project, which is currently under process. Both the projects were awarded through competitive bidding.

# Mumbai social worker Gauri Sawant becomes first transgender election ambassador

The Election Commission of India has appointed transgender social activist Gauri Sawant, as one of the 12 election ambassadors from Maharashtra. During 2004 and 2009 Lok Sabha elections there was no record of transgender voters.

Following the Supreme Court order, transgenders got the right to vote for the first time in 2014. In 2014, 918 voters were registered in this third category. This number has doubled in five years and now it is 2,086.

# Bihar celebrates its 107th foundation day

Bihar is celebrating its 107th foundation day on 22 March. It was on this day in 1912, Bihar was carved out of Bengal presidency.

A number of programmes are being organised to mark the occasion. Bihar Foundation organises Bihar day abroad including in US, Britain, Germany, Mauritius and Trinidad and Tobago.

### Ola's licence in Bengaluru suspended for six months

In a major development, the Karnataka transport department has suspended the licence of taxi aggregator Ola and ordered immediate stoppage of its services in Bengaluru. The action follows illegal operation of bike taxis by the company.

Bongaigaon Deputy Commissioner Adil Khan said that a special initiative has been taken to encourage the first-time voters. Mr. Khan said that the NIC team has developed the app and it will be launched soon. The new voters will also be able to sign a digital 'sankalp patra', promising to cast their votes on the day of polling.

#### Lalthlamuani is first woman to fight Mizoram LS poll

For the first time in the Lok Sabha elections in Mizoram, a woman, Lalthlamuani, 63, is trying her luck. The fate of all six candidates, including independent aspirant Lalthlamuani, will be decided on April 11.

Though women voters outnumber men in the parliamentary constituency, it's the first time that a woman has joined the race to challenge the hegemony of men to represent the lone Mizoram seat in the Lok Sabha.

# Rename Sultanpur as Khush Bhawanpur: UP Governor to Yogi

Uttar Pradesh Governor Ram Naik has written a letter to Chief Minister Yogi Adityanath to rename Sultanpur city as Khush Bhawanpur. Sultanpur is a city in Ayodhya Division of the state.

The Chief Minister has gained attention in the past for changing the names of Allahabad to Prayagraj and Faizabad to Ayodhya.

#### Govt sets up multi disciplinary terror action group for J&K

The Centre has set up a multi-disciplinary terror monitoring group (MDTMG) to ensure synergised and concerted action against terror financing and terror-related activities in Jammu and Kashmir.

According to an official order, the MDTMG will have representatives from the Jammu and Kashmir Police, Intelligence Bureau, CBI, NIA, and Income Tax Department. It will also take action against hardcore sympathisers among government employees, including teachers, who are providing covert or overt support to terror activities.

The ADGP CID of JK Police will head the MDTMG which will meet on a weekly basis and submit their action taken report regularly.

The Ministers from the 16 RCEP Participating Countries (RPCs) attended the 7th RCEP Intersessional Ministerial Meeting held in Siem Reap, Cambodia. Union Minister of Commerce & Industry and Civil Aviation, Suresh Prabhu attended the 7th RCEP Intersessional Ministerial Meeting in Cambodia.

The Ministers recalled the Leaders' determination to conclude a modern, comprehensive, high quality, and mutually beneficial RCEP in 2019, and resolved to exert utmost effort to achieve this target.

# Historic Guinness World Record in Yoga Made in Hong Kong

Taking the Yoga Day initiative of Prime Minister Narendra Modi to the next level, the Overseas President of BJP for Hong Kong & China, Sohan Goenka conducted a Japan Auction House Guinness World Record in Yoga.

The first of its kind in the history of Hong Kong; beating the previous record of 387, more than 1011 yoga practitioners attempted Virabathrasan (Warrior II Pose) for 3 minutes in one place and achieved the Guinness World Record at Sun Yat Sen Memorial Park, Hong Kong on 24th February.

#### **CURTAIN RAISER: AL NAGAH 2019**

Exercise Al Nagah III, third in the series of bilateral joint exercise between India and Oman is scheduled to be held from 12 to 25 March 2019 at Jabel Al Akhdar Mountains in Oman. The exercise will see both the armies exchanging expertise and experience in tactics, weapon handling and firing, with an aim to enhance interoperability in counterterrorist operations in semi urban mountainous terrain.

India-Oman bilateral security ties have continued to develop since the beginning of India-Oman Joint Military Cooperation meetings in 2006. Exercise Al Nagah III follows the first two joint exercises that were held in Oman in January 2015 and India in March 2017 respectively.

# National Common Mobility Card – India's First Indigenously developed Payment Platform launched by PM in Ahmedabad

One Nation, One Card for transport mobility was launched by Prime Minister Narendra Modi at a function in Ahmedabad . The Indigenous Automatic Fare Collection System based on One Nation One Card Model , National Common Mobility Card (NCMC) is the first of its kind in India.India's First Indigenously Developed Payment system for transport consisting of NCMC Card, SWEEKAR (SwachalitKiraya: Automatic Fare Collection System) and SWAGAT (Swachalit Gate) is based on NCMC Standards.

These are bank issued Debit/Credit/Prepaid cards and the customer may use this single card for payments across all segments including metro, bus, suburban railways, toll, parking, smart city and retail. The stored value on card supports offline transaction across all travel needs with minimal financial risk to involved stakeholders.

# **Independent Verification of Swachh Bharat Grameen confirms over 96% usage of toilets**

The National Annual Rural Sanitation Survey (NARSS) 2018-19, conducted by an Independent Verification Agency (IVA) under the World Bank support project to the Swachh Bharat Mission Grameen (SBM-G), has found that 96.5% of the households in rural India who have access to a toilet use it.

The survey was conducted between November 2018 and February 2019 and covered 92040 households in 6136 villages across States and UTs of India.

#### The key findings of NARSS 2018-19 are as follows:

- 93.1% of households were found to have access to toilets during the survey period (the corresponding figure as per the SBMG MIS in November 2018 was 96%)
- 96.5% of the people who had access to toilets used them
- 90.7% of villages which were previously declared and verified as ODF were confirmed to be ODF. The remaining villages also had sanitation coverage of about 93%
- 95.4% of the villages surveyed found to have minimal litter and minimal stagnant water.

### **Textiles Minister inaugurates Refurbished Handloom Haat**

Union Textiles Minister, Smriti Zubin Irani, inaugurated the renovated Handloom Haat in New Delhi. She also launched three projects of NIFT – VisionNXT – Trend Forecasting Initiative, Indian Textiles and Craft Repository and Design Innovation and Incubation.

The Haat at Janpath in New Delhi has been set up by Ministry of Textiles to provide marketing opportunities to authentic handloom products from various States, PSUs and cooperative societies.

Project related to trend innovation lab 'VisionNxt' initiativebeing set up by NIFT in the building will create an indigenous fashion forecasting service that endeavours to design seasonal directions for our country.

# Nepal Govt officials join INGAF training course in New Delhi

The Third group of 22 officials of Nepal's Ministry of Finance joined their training course on 'Global Perspectives on Public Financial Management' at the Institute of Government Accounts and Finance (INGAF) in New Delhi .

The training is being held under the Indian Technical and Economic Cooperation (ITEC) programme of the Ministry of External Affairs. The training will enhance capabilities of these officials in global practices dealing with e-payment system, accounting & cash management, public burrowing system, accounting of foreign loans/grants and repayments, pension payment system, internal audit, fiscal responsibility and budget management.

# India Signs Loan Agreement with the World Bank for USD 25.2 Million for Chhattisgarh Public Financial Management and Accountability Program

The Government of India, the State Government of Chhattisgarh and the World Bank signed a \$25.2 Million Loan Agreement to support the State's Reforms in Expenditure Management. This support will cover Expenditure Planning, Investment Management, Budget Execution, Public Procurement and Accountability.

The Chhattisgarh Public Financial Management and Accountability Program, which is the First Bank-Financed State-Level Project in Chhattisgarh in nearly a decade, will also help the State strengthen its Direct Benefit Transfer (DBT) and Tax Administration Systems.

# India signs Loan Agreement with the World Bank for USD 96 Million for Additional Financing for Uttarakhand Disaster Recovery Project

The World Bank, Government of India and Government of Uttarakhand (GoUK) signed a \$96 Million Loan Agreement to provide additional funds to the State of Uttarakhand in its post-disaster recovery plans, ongoing since the floods of 2013, as well as strengthen its capacity for Disaster Risk Management.

New Delhi Municipal Council area gets cleanest small city award while Uttarakhand's Gauchar was adjudged Best Ganga Town in the survey. Top ranked cities received a statue of Father of the Nation Mahatma Gandhi as award for their work towards cleanliness. Swachh Survekshan 2019 covered all Urban Local Bodies in the country, making it the largest such cleanliness survey in the world.

Over 5 years, the total research funding for the Initiative shall be £10 million (approx. Rs. 90 crores). CRUK's share for such funding shall be £5 million (approx. Rs. 45 crores). DBT shall match such funding by £5 million (approx. Rs. 45 crores).

# Cabinet approves MoU between India and Germany on Cooperation in the field of Occupational Safety and Health

A 60-member strong Indian Army contingent, based in northern command headquarters at Udhampur in Jammu and Kashmir, is taking part in the military exercise 'Al-Nagah III'.

### India-Africa joint field training exercise to kick off on March 18

A 10-day long Africa-India Joint Field Training Exercise **(AFINDEX-19)** between the Indian Army and 16 African nations will be conducted in Pune from March 18 to 27.

As many as 10 personnel, each from the participating nations from the African continent and personnel of Maratha Light Infantry of Indian Army, will participate in the joint exercise which will be conducted at two locations in Pune's Foreign Training Node at Aundh Military Station and College of Military Engineering in Kirkee.

# India, Myanmar conduct coordinated operation against insurgents posing threat to Kaladan project

The armies of India and Myanmar conducted a "coordinated operation" from February 17 to March 2 against insurgents in Myanmarese territory to avert a possible threat to the Kaladan multi-modal transit transport project. However, the Indian Army did not cross the border during the operation.

The focus of the operation was to crack down on the members of the Arakan Army, an insurgent group in Myanmar.

interoperability and comradeship between the two forces and was designed to enhance the capabilities of both Indian and U.S. armed forces, it said.

'Vijit' meaning "Winner or Victorious" is the testimony of India's shipbuilding capabilities and the resolve of Govt of India to safeguard country's maritime interests,".

# Indo-Bangla Army teams go rafting over Siyom river in Arunachal Pradesh

The three-day long joint Indo-Bangladesh White Water Rafting Expedition started from Tumbin in Arunachal Pradesh and came to an end at Pangin. # India to provide aid to people affected by cyclone 'IDAI' in Mozambique

India has decided to divert three Indian naval ships to the port city of Beira in Mozambique to provide humanitarian assistance to the people affected by tropical cyclone 'IDAI'.

External Affairs Ministry in a release said the ships will provide relief materials in the form of food, clothes and medicines. Three medical practitioners and five nurses will provide immediate medical help.

### Opening ceremony: Africa-India Field Training Exercise-2019

The inaugural Africa-India Field Training Exercise-2019 for India and African nations called AFINDEX-19 scheduled from 18 March to 27 March 2019 started with a grand opening ceremony on 18 March 2019 at Aundh Military Station, Pune.

The aim of the exercise is to practice the participating nations in planning and conduct of Humanitarian Mine Assistance and Peace Keeping Operations under Chapter VII of United Nations Peace Keeping Operations.

#### Indo-Sri Lanka joint Exercise Mitra shakti-VI

Exercise MITRA SHAKTI is conducted annually as part of military diplomacy and interaction between armies of India & Sri Lanka. The joint exercise for the year 2018-19 will be conducted from 26 March to 08 April 2019 in Sri Lanka.

The aim of the exercise is to build and promote close relations between armies of both the countries and to enhance ability of joint exercise commander to take military contingents of both nations under command.

### 33rd Edition of India-Indonesia Coordinated Patrol (Ind-Indo Corpat) Commences at Port Blair

Indonesian Naval Ship KRI Sultan Thaha Syaifuddin and Maritime Patrol Aircraft CN-235 led by Cmde Dafit Santoso arrived at Port Blair, Andaman & Nicobar Islands, India for the Opening Ceremony of the 33rd edition of the India-Indonesia Coordinated Patrol (IND-INDO CORPAT) to be held from 19 Mar to 04 Apr 2019.

The ED of World Bank for Bangladesh, Bhutan, India and Sri Lanka has made the visit to Bhutan after release of a working paper of World Bank titled 'Bhutan Development Report-A Path to Inclusive and Sustainable Development' where it was stated that due to Bhutan's small domestic market, sparse population, and high transportation costs, the risks associated with private investment are comparatively higher.

#### US, South Korea Call Off Foal Eagle and Key Resolve Exercises, Announce New Exercise

The United States and South Korea decided to call off their joint exercise "Foal Eagle" and "Key Resolve" and instead bifurcate them into smaller exercises. This is being done to ease tensions with North Korea. "Key Resolve" will be replaced by "Dongmaeng" which is also known as alliance in English, Foal Eagle drills will be replaced by a smaller battalion-sized exercise.

This decision has been made after there was a failure to reach an agreement on denuclearisation during the summit in Hanoi, Vietnam between President Donald Trump and North Korean leader Kim Jong Un.

# Two Nobel Prizes for literature will be awarded this year: Swedish Academy

The Swedish Academy has said that two Nobel Prizes for literature will be awarded this year. The decision comes after a sex scandal causing the suspension of the award last year. The Academy in a statement at Stockholm yesterday said the Nobel Prize in Literature will awarded this autumn for both 2018 and 2019.

The much-awaited award had to be postponed last year for the first time since 1949 after the Academy, which annually chooses the winner.

# China slashes GDP growth target to 6-6.5% amid slowdown, trade war with US

China has slashed its official GDP target to 6 to 6.5 per cent this year as the world's second largest economy grapples with the ongoing trade war with the US and a continued economic slowdown.

The lowered growth rate was proposed by Chinese Premier Li Keqiang in his work report for this year at the opening session of the annual session of the "rubber-stamp" Parliament, the National People's Congress (NPC).

### Google launches 'Bolo' App to tutor children to read Hindi, English

Tech giant Google unveiled a new app 'Bolo' that aims to help children in primary school learn to read in Hindi and English. The free app, which is being launched in India first, uses Google's speech recognition and text-to-speech technology.

The app features an animated character 'Diya', who encourages children to read stories aloud and helps if the child is unable to pronounce a word. It also lauds the reader when he/she completes the reading.

### **OECD** cuts global growth forecast

The Organisation for Economic Co-operation and Development, OECD, has again cut its 2019 forecast for global economic growth due to ongoing trade tensions and Brexit uncertainty. the OECD lowered its forecast to 3.3 per cent for this year, down from the 3.5 per cent it predicted in November, which was itself a downgrade from a previous 3.7 per cent.

# **Malaysia joined International Criminal Court**

Malaysia has become a member of the International Criminal Court in a boost for the beleaguered institution at a time it faces growing criticism. Malaysia becomes the 124th member of the court since its establishment in 2002. "By joining the ICC, Kuala Lumpur can now play an important role in issues related to crimes against humanity.

# Venezuela orders German ambassador to leave the country

The Venezuelan government ordered the German ambassador Daniel Kriener to leave the country after he expressed support for Juan Guaido, escalating a

diplomatic standoff with a group of about 50 nations that recognize the opposition leader as the country's interim president.

#### 116-year-old Japanese woman officially named oldest person

A 116-year-old Japanese woman has been honoured as the world's oldest living person by Guinness World Records. The global authority on records officially recognised Kane Tanaka in a ceremony at the nursing home where she lives in Fukuoka, in southwest Japan. Her family was present to celebrate.

Born in January 1903, Tanaka loves playing the board game 'Othello' and enjoys studying mathematics.

The previous oldest living person was another Japanese woman, Chiyo Miyako, who passed away last July, aged 117.

#### Bill Shine resigns as Donald Trump's communications director

US has said Former Fox News executive Bill Shine has resigned as President Donald Trump's communications director.

### Saudi Arabia replaces India as world's largest arms importer

Saudi Arabia has now become the largest importer of arms in the world, having pushed India to the second spot, according to the premier Stockholm International Peace Research Institute (SIPRI).

the institute identified Saudi Arabia, India, Egypt, Australia and Algeria as the five top arms importing countries and the United States, Russia, France, Germany and China as the five top arms exporting nations.

For more than the last eight years, India was the largest arms importer in the international market.

### Google phases out instant messaging app 'Allo'

After pausing investments in its "Allo" mobile messaging app, Google has finally bid goodbye to the platform that was launched with much fanfare in 2016.

#### Swedish activist nominated for Nobel Peace Prize

Greta Thunberg, a 16-year-old Swedish activist who is a prominent voice in the fight against climate change, has been nominated for the Nobel Peace Prize this year.

This year's Nobel Peace Prize has 304 candidates, of which 219 are individuals and 85 organisations, the Norwegian Nobel Committee reported last month. The Nobel prizes are awarded each year on December 10, coinciding with the anniversary of the death of its founder Alfred Nobel.

#### US jury awards Qualcomm \$31 mn in Apple case

A US jury has decided that Apple needs to pay chip-maker Qualcomm \$31 million for violating three of its patents. "Apple violated three Qualcomm patents and should pay the chip-maker \$31 million for infringing on its technology," the jury decided.

One Qualcomm patent allows a smartphone to quickly connect to the Internet once the device is turned on. Another one deals with graphics processing and battery life, while the third lets apps on smartphone download data more easily.

# Interactive art 'theme park' to open in New York

A New York-based design studio is set to unveil an interactive art 'theme park' in the city that will host three playful installations a year. The exhibition titled "Snark Park", will be displayed at a space in the city's Hudson Yard area.

Previous interactive installations by the design studio, Snarkitecture, which was established in 2008 by Daniel Arsham and Alex Mustonen, took over galleries, shopping malls and public spaces around the world.

# World commits to reduce single-use plastics by 2030

After five days of talks at the Fourth UN Environment Assembly in Nairobi ,Kenyan capital, ministers from more than 170 UN member states delivered a

bold blueprint for change, saying the world needed to speed up moves towards a new model of development in order to respect the vision laid out in the Sustainable Development Goals for 2030.

They also expressed support for UN Environment's efforts to develop a global environmental data strategy by 2025.

#### Cyclone Idai hits Mozambique, Malawi, Zimbabwe

Mozambique, Zimbabwe and Malawi have been hit by a vicious cyclone that has killed nearly 150 people, left hundreds more missing and stranded tens of thousands.

According to the UN and government officials, Cyclone Idai has affected more than 1.5 million people in the three southern African countries.

#### Golden Globes sets 2020 date

The Hollywood Foreign Press Association has set next years Golden Globes ceremony for January 5, 2020.

The Globes fall just two days before Oscar nomination balloting closes on January 7 so Globes outcomes likely won't have as much of an impact on Academy voters as they may have had in 2019 when there was a bigger gap between the two dates.

Nominations for the 92nd Oscars will be announced on January 13, 2020 with the ceremony set for February

The 76th Golden Globe Awards held on January 7, 2019, witnessed all the diverse men and women take home trophies in a proud evening which turned slightly surprising when Bohemian Rhapsody and its lead star Rami Malek were declared as the Best Motion Picture (Drama) and the Best Actor, respectively.

# China conducts world's 1st remote surgery using 5G

The first remote surgery on a human using 5G technology was successfully conducted in China.

The process was made possible with the low-latency 5G technology provided by Huawei and China Mobile, which enabled near instantaneous data transmission.

5G technology was used in a surgery conducted on a pig last year, when a doctor from 301 Hospital in Beijing removed part of a pig's liver using two robot arms in Fuzhou, the capital of East China's Fujian Province.

It was the world's first remote surgery using 5G mobile network technology on an animal.

#### SaaS start-up Freshworks opens office in Singapore

Chennai-based Software-as-a-Service (SaaS) unicorn Freshworks which provides Cloud-based business software has expanded to the Asean market with the setting up of a regional hub in Singapore.

By opening its first regional hub for the Asean market, Freshworks said it aims to expand adoption of its customer engagement suite and increase its network of partner resources to meet rising customer demand in the region.

The Freshworks regional hub was set up with support from the Singapore Economic Development Board (EDB).

# EU regulators fine Google €1.49 billion for blocking rival online search advertisers

European Union (EU) antitrust regulators handed down a €1.49 billion fine to Google for blocking rival online search advertisers, marking the company's third penalty in two years.

EU's competition commissioner Margrethe Vestager announced the results of the long-running probe of Google's AdSense advertising business at a news conference in Brussels on Wednesday.

The commission found that Google and its parent company, Alphabet, breached the EU antitrust rules by imposing restrictive clauses in contracts with websites that used AdSense, preventing Google rivals from placing their ads on these sites.

# Russian defence minister meets Syrian president

Russian Defence Minister Sergei Shoigu visited Syria on the instruction of President Vladimir Putin and held talks with Syrian President Bashar al-Assad.

Shoigu delivered a message from Putin to Assad, and they discussed fighting international terrorism in Syria, various aspects of security in the Middle East and post-conflict settlement.

#### US, Brazil sign space technology safeguard agreement

The US has signed an agreement with Brazil to protect its technology associated with US participation in space launches in the South American country.

The agreement is about "technology safeguards associated with US participation in space launches from Brazil.

#### Russia-US' Venus space probe to be launched in 2027

A Russian-US joint interplanetary probe to Venus will be possibly launched in 2027.

"The launch windows in 2026, at the end of 2027, in 2029 and 2031 are being discussed. Even if the financing starts this year, we are missing the first date, so it will most likely be 2027", Lyudmila Zasova, a researcher at the Space Research Institute under the Russian Academy of Sciences, was quoted as saying in an interview with Sputniknews agency.

The Venera-D space mission, a joint project to land on Venus, involves Russian orbital and landing gear and a small US scientific station.

# US to build first exascale supercomputer in 2021

The US has disclosed its plan to build an exascale supercomputer, about seven times the speed rating of the most powerful system built to date.

The US Department of Energy (DOE) granted a \$500 million contract to Intel and sub-contractor Cray Computing and the supercomputer, called Aurora, will be delivered to the department's Argonne National Laboratory near Chicogo in 2021.

The IBM supercomputer is currently ranked the fastest computing system in the world, a notch occupied by China's Sunway TaihuLight and Tianhe 2A for five years.

#### Kazakhstan President resigns after nearly 30 years in power

Kazakhstan President Nursultan Nazarbayev has announced his resignation after nearly 30 years in power.

The 78-year old leader had ruled the country since it emerged from the collapse of the Soviet Union in the early 1990s.

#### Kazakhstan renames capital 'Nursultan' after ex-President

Kazakhstan has renamed its capital Astana to Nursultan to honour outgoing leader Nursultan Nazarbayev, who unexpectedly resigned .

The change was announced after Kassym-Jomart Tokayev was sworn in as president, promising to seek his predecessor's opinion on key decisions.

Mr Nazarbayev, 78, served nearly 30 years as leader of the oil-rich nation.

#### Finland ranked happiest country for second year

Finland has topped a global happiness ranking for the second year in a row. It beat Nordic peers Denmark, Norway and Iceland in a ranking of 156 countries by the United Nations Sustainable Development Solutions Network. The ranking saw the US drop one place, to 19th, while people in South Sudan were the least happy. India dropped seven ranks to the 140th place.

The results are based on an average of three years of surveys taken by Gallup between 2016 and 2018 and include factors such as gross domestic product, social support from friends and family, healthy life expectancy, freedom to make life choices, generosity, perceived corruption and recent emotions — both happy and sad.

# Flipkart introduces robot-based sortation technology

Flipkart has introduced a robot-based sortation technology — Automated Guided Vehicles (AGVs) at its Soukya sortation center in Bengaluru. Designed to optimise efficiency and precision on the back-end of the supply chain, these AGVs will help Flipkart meet growing customer demand, ensuring faster delivery and a better experience for online shoppers.

The Soukya set-up involves over 100 self-guided bots that automatically sort packages to the right customer pincodes by identifying encoded information on

each package. It can process up to 4,500 shipments in an hour and can be scaled over five times with minimal changes, enabling better throughput from an existing facility, removing the need for space expansion and enabling the current manpower allocated to the task to be upskilled to do higher value-adding work.

#### Pakistan to receive over 2 billion US Dollars loan from China

Cash-strapped Pakistan will receive over 2 billion US Dollars loan from China to provide a boost to its ailing economy.

Pakistan's Finance Ministry has announced that all procedural formalities for the transfer of the 2.1 billion US Dollars loan being provided by the Chinese government have been completed, and the funds will be deposited in the State Bank of Pakistan's account .

Pakistan has received 1 billion US dollars each from Saudi Arabia and the UAE, as part of the bailout packages by the two Gulf nations to help shore up Islamabad's dwindling foreign currency reserves.

#### **British PM at European Council summit in Brussels**

British Prime Minister Theresa May is attending the crucial European Council summit at Brussels. At the meeting, Ms May will put her case before European Union leaders for an extension to the Brexit withdrawal process till 30th of June.

Talking to reporters ahead of the summit, the Prime Minister said, a short extension would give British Parliament time to make a final choice that delivers on the result of the referendum. She said, what matters is that they recognize that Brexit is the decision of the British people and they deliver on the vote of the people.

# Marcelo Gleiser, Physicist, Wins 2019 Templeton Prize

Dartmouth College physicist and astronomer Marcelo Gleiser is the 2019 Templeton Prize winner, the Templeton Foundation announced. Born in Brazil, Gleiser is the first Latin American to be awarded the prize, which "recognizes living individuals for their contribution to affirming life's spiritual dimension," according to a statement from the foundation.

In addition to his role as Appleton professor of natural philosophy and a professor of physics and astronomy at Dartmouth, Gleiser is the author of five

books, including The Dancing Universe (Plume, 1998) and The Island of Knowledge (Basic, 2015).

# Jimmy Carter becomes longest living chief executive in American history

Former US president Jimmy Carter has reached a milestone. Elected as the 39th President, Carter is now the longest living chief executive in American history. Today is the 172nd day beyond Carter's 94th birthday. It exceeds by one day the lifespan of former President George H.W. Bush, who died last November at the age of 94 years, 171 days. Both men were born in 1924: Bush on June 12, Carter on Oct. 1.

#### Italy becomes first G7 nation to join China's BRI

Despite a warning by United States, Italy joined China's signature foreign policy Belt and Road initiative (BRI), making it the first G7 country to officially do so reports Xinhua.

#### Norway to put world's 1st wireless e-cab charging stations

Norway's capital Oslo will become the world's first city to install wireless induction-based fast-charging systems for electric taxis, Reuters reported. Charging plates will be installed in the ground where taxis are parked, which will connect with receivers in taxis and allow them to charge for up to 75 kilowatts. Finland's Fortum is working on the project with America's Momentum Dynamics.

# Oman signs agreement allowing United States military to use its port

Oman has signed an agreement with the United States that allow American ships and warplanes to take advantage of his ports and airports. The state-run Oman News Agency said the framework agreement is aimed at bolstering Omani-American military relations.

The agreement will allow the US forces to take advantage from the facilities offered at some of the Sultanate's ports and airports during visits of the US military vessels and aircraft, particularly in the port of Duqm, it said.

#### World's largest e-waste recycling hub opens in Dubai

The world's largest e-waste recycling facility has opened in Dubai. Located at the Dubai Industrial Park, the 280,000 square feet plant will process Waste Electrical and Electronic Equipment (WEEE), IT asset disposition (ITAD), refrigerant gas and specialised waste.

The facility will utilise state-of-the-art reclamation technology, which surpasses the European Union's standards for e-waste. It has a processing capacity of 100,000 tonnes of total integrated waste per year, of which 39,000 tonnes is e-waste.

### Sri Lanka to launch Smart City concept

Under the government's Smart City project, 2,500 schools will be connected through a wireless connection to enable smart education in Sri Lanka.

Peter Tabichi, 36, a maths and physics teacher at Keriko secondary school in Pwani Village, in a remote part of Kenya's Rift Valley, has won the Varkey Foundation Global Teacher Prize 2019.

# Israel unveils world's longest salt cave

Israeli researchers say they have discovered the world's longest salt cave near the desert site where, according to the Bible, Lot's wife was turned into a pillar of salt.

The 10-km long warren of underground passages and chambers in Mount Sodom, overlooking the Dead Sea, was mapped out over two years by cavers from nine countries, led by the Hebrew University of Jerusalem. The cave is called Malham.

#### Germany adds six months to Saudi arms export ban

NSD Logo Germany has extended by six months an embargo on weapons exports to Saudi Arabia, instituted last October.

Government spokesman Steffen Seibert said in a statement order to halt authorised weapons exports to Saudi Arabia is extended by six months from March 31 to September 30, 2019.

#### Google dropped from LGBT equality index

**An anti-LGBTQ app** on the PlayStore that influences a person's sexual orientation using psychological or spiritual interventions has raised questions about Google's corporate equality ideals leading to the search engine's suspension from the CEI rating.

US-based LGBTQ civil rights advocacy group Human Rights Campaign (HRC) Foundation has suspended Google from its 2019 Corporate Equality Index (CEI) for failing to remove the app from PlayStore.

In 2018, Google scored a full 100 per cent on the CEI report.

# 2019 UNDP human development report to focus on inequality

The 2019 Human Development Report (HDR), with its **focus on inequality**, will be released around this year's last quarter, the UNDP said. The report will provide a comprehensive picture of the many forms of inequality that are shaping the 21st century. In a statement, the United Nations Development Programme acknowledged that today's world remains deeply unfair.

It said: "The life and prospects faced by a newborn in a poor country or in a poor household are radically different from those of wealthier children. In all societies, long-standing forms of inequality persist while gaps are opening in new aspects of life".

# In world first, HIV-positive woman donates kidney to HIV-positive recipient

An Atlanta woman Nina Martinez became the first living HIV-positive kidney donor in the world when surgeons at Johns Hopkins Medicine in

Baltimore transferred her organ to a recipient who is also HIV-positive. Both the donor and the recipient, who wishes to remain anonymous, are doing well.

Nina Martinez, a 36-year-old public health consultant, acquired HIV as a 6-week-old in 1983, when she received a blood transfusion in the years before blood banks began routine testing for the virus. HIV damages the immune system and interferes with the body's ability to fight the organisms that cause disease.

## Shanghai world's first district with 5G coverage, broadband gigabit network

Shanghai claimed has become the world's first district using both 5G coverage and broadband gigabit network as China seeks to establish lead over the US and other countries in the race to develop next generation cellular mobile communications.

5G is the next generation of cellular technology with download speeds that are 10 to 100 times faster than 4G LTE networks.

## SpaceX launches unmanned US space capsule to space station

A SpaceX rocket with a newly designed unmanned crew capsule blasted off for the International Space Station, in a key milestone for Elon Musk's space company and NASA's long-delayed goal to resume human spaceflight from U.S. soil later this year.

SpaceX's 16-foot-tall (4.9 meter) Crew Dragon capsule, atop a Falcon 9 rocket, lifted off from Florida's Kennedy Space Center .

The 55-year-old renowned scientist was appointed as the chairman of Defence Research Development Organisation (DRDO) last year.

## ISRO Unveils 'Young Scientist' Programme to Train Students in Space Science

State-run Indian Space Research Organisation (ISRO) announced the launch of its Young Scientist programme to train class 9 students in space technology and its applications.

"ISRO has launched the special programme for school children 'Yuva Vigyani Karyakram' (Young Scientist programme) to impart basic knowledge on space technology, space science and applications to the young ones to arouse their interest in space activities.

## Nasa astronauts to carry out first all-female spacewalk

NASA astronauts Anne McClain and Christina Koch will conduct an all-female spacewalk for the first time in history, along with Canadian Space Agency flight controller Kristen Facciol.

As part of Expedition 59, NASA astronauts McClain and Koch will carry out the spacewalk on March 29. They'll be supported on the ground by Facciol, who will be on the console at NASA's Johnson Space Center in Houston.

### Pinaka guided weapons system successfully test fired

Defence Research and Development organisation, DRDo successfully test fired the PINAKA guided WEAPON rocket system from Pokhran range in Rajasthan. the weapon system is equipped with state-of-the-art guidance kit comprising of an advanced navigation and control system. The weapon systems impacted the intended targets with high precision and achieved desired accuracies.

MPATGM is incorporated with advanced features including state-of-the-art Imaging Infrared Radar (IIR) Seeker with integrated avionics. The first test was conducted on 13th March 2019. In both the missions, the missiles hit the designated targets precisely at different ranges. All the mission objectives have been met.

## IIT Roorkee ties up with ISRO for space tech cell

The Indian Institute of Technology (IIT) Roorkee in Uttarakhand tied up with the Indian Space Research Organisation (ISRO) to set up a Space Technology Cell at its campus. The ISRO-IIT Roorkee Space Technology Cell shall pursue advanced research in the areas of relevance to the future technological and programmatic needs of the Indian space programme.

The cell shall ensure to maximise the use of research potential, infrastructure, expertise and experience that exist in ISRO and IIT Roorkee. The institute will be providing the infrastructure and administrative support in setting up of the cell.

## First Afghan shipment to India via Chabahar arrives in Mumbai's Nhava Sheva port

In a major boost to ties between India and Afghanistan, the first Afghan shipment to India via Chabahar arrived at Nhava Sheva port in Mumbai. The 570 tonnes of consignment contained mung beans and talc.

### Xiaomi launches Mi Pay to take on Google Pay, Paytm

Aiming to take on the likes of Google Pay and Paytm, Chinese handset maker Xiaomi launched its Unified Payments Interface (UPI)-based payments application "Mi Pay" for its MIUI users in India.

According to the company, the Mi Pay service aims to be an all-in-one payments solution for its users. It would be available for all Xiaomi devices running its proprietary MIUI OS based on Android.

### Mobile app developed by IIPHG, PHFI to combat exam pressure

A mobile application to cope with exam related stress and anxiety for students and their parents has been developed by Indian Institute of Public Health Gandhinagar, Gujarat, (IIPHG) in collaboration with National Mental Health Program, Department of Health and Family Welfare, Government of Gujarat. The mobile application is called 'Conquer Exam, Be a Warrior.'

### IBM creates Blockchain-based global payment network

Information Technology (IT) major IBM has created a Blockchain-based global payment network that transmits monetary value in the form of digital assets, commonly known as cryptocurrencies or "stable coins."

The payment network called World Wire uses the Stellar protocol that reduces intermediaries and allows users to accelerate settlement time. World Wire has already enabled payment locations in 72 countries, with 47 currencies and 44 banking endpoints.

## SpiceJet becomes first Indian low-cost airline to join IATA

SpiceJet has joined global airlines' grouping IATA as a member, becoming the first Indian low-cost carrier to get the membership. The International Air

Transport Association (IATA) represents more than 290 airlines, including Air India, Jet Airways and Vistara.

The membership allows the airline to "explore and grow its collaborations with international member airlines of IATA through interlining and code shares, enabling SpiceJet to seamlessly expand the network options for its passengers in future.

### India will launch electronic intelligence satellite Emisat on April 1

India on April 1 will launch an electronic intelligence satellite Emisat for the Defence Research Development Organisation (DRDO) along with 28 third party satellites and also demonstrate its new technologies like three different orbits with a new variant of PSLV rocket, ISRO said .

According to Indian Space Research Organisation (ISRO), a new variant of its Polar Satellite Launch Vehicle (PSLV) rocket will first put the 436 kg Emisat into a 749 km orbit.

### INS Kadmatt at Langkawi, Malaysia to Participate in LIMA-19

Indian Navy's frontline ASW corvette, INS Kadmatt arrived at Langkawi, Malaysia on a seven days official visit. The ship is scheduled to participate in the 15th edition of Langkawi International Maritime and Aerospace Exhibition, LIMA-19 during the visit. Vice Admiral Karambir Singh, PVSM, AVSM, ADC, Flag Officer Commanding-in-Chief, Eastern Naval Command would also be attending various engagements as part of LIMA 19 as head of Indian Navy Delegation

INS Kadmatt (P 29) is an indigenous stealth anti-submarine warfare corvette and was commissioned into the Indian Navy in January 2016.

## ISRO to launch 29 satellites including EMISAT on first of April

Indian Space Research Organisation (ISRO) will launch 29 satellites including the primary payload EMISAT, on the first of April. Polar Satellite Launch Vehicle, PSLV-C45 will take off from Satish Dhawan Space Centre in Sriharikota tentatively at 9:30 AM carrying the satellites onboard.

EMISAT has been developed for monitoring radar network by India. An ISRO release says, EMISAT, weighing 436 kg, is intended for electromagnetic spectrum

measurement. It will be placed in an orbit of about 753 km altitude. The customer payloads are from Lithuania, Spain, Switzerland and the US. They will be hurled into space at an altitude of about 505 km.

### India successfully tests anti-satellite missile

Defence Research and Development Organisation, DRDO on Wednesday successfully conducted an Anti-Satellite (A-SAT) missile test, Mission Shakti from Dr A P J Abdul Kalam Island in Odisha.

A DRDO – developed Ballistic Missile, Defence Interceptor Missile successfully engaged an Indian orbiting target satellite in Low Earth Orbit (LEO) in a Hit to Kill mode. the interceptor missile was a three-stage missile with two solid rocket boosters. Tracking data from range sensors has confirmed that the mission met all its objectives.

#### India gets anti-satellite capability to become space superpower: PM

India became "a space superpower" by becoming the fourth country to acquire anti-satellite capability, Prime Minister Narendra Modi announced.

"Our scientists, a little while ago, have targeted a live satellite in space 300 km away in low earth orbit," he said .

"The pre-fixed target was destroyed by the A-SAT in just three minutes. With this, India has established itself as a space superpower." Mission Shakti was a difficult operation but a huge success," the Prime Minister added.

## IIT-Delhi develops AI-based system to detect malaria, other diseases

Researchers at the **Indian Institute of Technology-Delhi** have developed an Artificial Intelligence-based electronic hardware system to detect malaria, tuberculosis, intestinal parasite, and cervical cancer in milliseconds. their system can be used for healthcare access in resource-constrained areas with limited access to human specialists.

"Microscopy-based diagnosis depends on availability of skilled technicians, of which there is a critical shortage. As a result, diagnoses are often made on the basis of clinical signs and symptoms alone, which is error-prone," the institute said.

### ISRO to launch country's latest observation satellite EMISAT

Indian Space Research Organisation (ISRO) will launch the country's latest observation satellite EMISAT.

The launch vehicle PSLV-C45 will lift off from the Satish Dhawan Space Centre, in Sriharikotta at with EMISAT and 28 other customer payloads. The countdown for the launch mission is progressing smoothly at the launchpad.

RD Murgan also from CISF got third place. A total nine CISF personnel participated in 10 KM race category. The remaining seven personnel also successfully completed run and received Certificate of Achievement.

COAS Open Marathon and Run for Fun is an annual event organised by the Nepal Army.

#### **Cricket set for Asian Games return in 2022**

Cricket is set for a return at the Asian Games after the Olympic Council of Asia (OCA) on March 3 included it in the sports programme for the 2022 edition in Hangzhou. The decision was taken at the OCA's General Assembly in Bangkok.

Cricket was dropped from the 2018 Asian Games in Indonesia after featuring in 2010 and 2014, albeit without the presence of game's powerhouse India. India opted out of the quadrennial event owing to the team's congested scheduling.

### Wrestler Bajrang Punia wins gold in Bulgaria

India's star wrestler Bajrang Punia has won a gold medal in 65-kilogram freestyle in Bulgaria. The tournament is being held at the Dan Kolov-Nikola Petrov in Ruse. Punia dedicated the victory to Indian Air Force Wing Commander Abhinandan Varthaman, from whom Punia said he got inspiration.

Punia, a World Championship silver medallist, overpowered Jordan Oliver of USA 12-3 in the final yesterday. He also secured the maximum ranking points from the tournament.

This was Punia's 10th medal in as many international tournaments since the 2017 World Championships in Paris.

### ICC bans former Zimbabwe Cricket Director Enock Ikope for 10 years

Former Zimbabwe Cricket Director Enock Ikope has been banned from all cricket for 10 years after the ICC Anti-Corruption Tribunal found him guilty of non-cooperation and obstruction of investigations.

The Tribunal heard evidence that the ACU had established information during its investigation into the corrupt approach made by Rajan Nayer to Zimbabwe cricket Captain Graeme Cremer, which gave the ACU reasonable grounds to suspect that Ikope may have engaged in corrupt conduct under the Code.

Rohit achieved the feat in India in his 57th innings, with Hashim Amla achieving the feat in 57 innings in South Africa. Virat Kohli achieved the feat in India in 63 innings.

## Assam's Shiva Thapa wins silver at GeeBee Boxing Tournament in Finland

Three-time Asian medallist Shiva Thapa (60 kg) has brought laurels to Assam and the country by winning silver at the 38th GeeBee Boxing Tournament in Finland's Helsinki.

India's Kavinder Singh Bisht (56kg) struck gold while four others including Thapa claimed silver medals to end a fine Indian campaign at the tournament on Sunday.

Besides Shiva Thapa, the other silver medallists are Govind Sahani (49 kg), Commonwealth Games bronze-medallist Mohammed Hussamuddin (56 kg) and Dinesh Dagar (69 kg).

## Prajnesh Gunneswaran stuns Nikoloz Basilashvili at Indian Wells

In tennis, Indian qualifier Prajnesh Gunneswaran achieved the biggest win of his career when he stunningly knocked world number 18 Nikoloz Basilashvili out of the Indian Wells ATP Masters event in the USA.

### FIFA mulls expanding 2022 World Cup to 48 teams

The 2022 football Qatar World Cup may see an expansion from 32 to 48 teams, the FIFA President Giovanni Infantino, has said.

FIFA decided in 2018 that the 2026 World Cup, to be hosted by the US, Canada and Mexico, would use the new 48-team format. The feasibility study has identified potential venues in Qatar's neighbourhood Bahrain, Kuwait, Saudi Arabia, Oman and the United Arab Emirates that could host the 16 additional matches.

### India to host FIFA U-17 Women's World Cup in 2020

India were awarded the rights to host the FIFA U17 Women's World Cup in 2020. The decision to award the rights to India was taken at the FIFA Council meeting in Miami.

By virtue of being the host country, India will take part in the tournament for the first time in its history. In 2017, India had hosted the Under-17 Men's FIFA World Cup.

## Argentina, Colombia set to be co-hosts of 2020 Copa America

Argentina and Colombia are poised to co-host the 2020 Copa America after South America's ruling body CONMEBOL once again ruled out a US proposal to host the tournament.

CONMEBOL, which comprises the 10 member federations in South America, said in a statement it had accepted "the nomination of Argentina and Colombia as joint venues for the 2020 edition of the Copa America."

## India thrash Sri Lanka by 5-0 in 5th SAFF Women's C'ship

Defending champion India thrashed Sri Lanka by 5-0 in the 5th South Asian Football Federation, SAFF Women's Championship in Biratnagar, Nepal . Indian girls dominated the entire game and took a 4-0 lead in the first half. Grace Dangmei, Sandhya Ranganathan, Indumati and Sangeeta scored goals.

This is team India's 21st victory and it has won the championship four times in the past.

### Kohli, Bumrah retain top spots in ICC ODI rankings

India skipper Virat Kohli and pacer Jasprit Bumrah have retained their top positions in the batsmen and bowlers' list of the latest ICC ODI rankings. Kohli remained at number one spot after scoring 310 in the recently-concluded home series against Australia while his deputy Rohit Sharma hit 202 runs to maintain the No.2 spot in the batting chart.

Kedar Jadhav's all-round effort has helped him move up 11 places to a career-best 24th after the five-match series, which India lost 2-3. Meanwhile, South Africa opener Quinton de Kock has grabbed fourth position after playing a huge part in his team's 5-0 victory over Sri Lanka. New Zealand's Ross Taylor has maintained the number three spot.

In bowlers' list, Bumrah is sitting at the top with 774 points. Among others, New Zealand fast bowler Trent Boult has moved up a place to second. The all-rounders' table continued to be headed by Rashid Khan. However, there are no Indian figures in the top-5.

## Special Olympics: India bags 70 medals

In Special Olympics, India have bagged 70 medals including 18 golds, 22 silver and 30 bronze, so far, at Abu Dhabi. Team Bharat clinched a whopping 55 medals, including 14 gold.

In Roller Skating, Supreet Singh from Haryana in 1000-meter, Rishabh Jain from New Delhi in 1000-meter and Priya Prakash Gada from Maharashtra in 100-meter won a Gold Medal each. Amanjot Singh won gold in the squat contest after lifting 385kg.

Indian roller skaters bagged a staggering 29 medals comprising nine golds, 13 silver and two bronze.

## FIFA to make public the vote for 2023 Women's World Cup

FIFA will make public its vote on the host for the 2023 Women's World Cup. It could be the most hotly contested bidding process for the tournament, which was

first staged in 1991. Australia, Colombia, Japan and South Africa have been exploring bids. South Korea submitted a proposal to DPK Korea to jointly bid.

The United States, Canada and Mexico were chosen last year to host the 2026 World Cup. The votes by the FIFA Congress of all member associations were published. Previously, the decisions were taken in private by FIFA executive committee, which was renamed the FIFA Council in 2016.

### **Athlete Irfan qualifies for Tokyo Olympics**

Indian athlete K.T. Irfan has qualified for the Tokyo Olympics as he finished fourth in the men's 20 kilometre category at the Asian Race Walking Championships .

The 29-year-old clocked 1 hour 20 minutes and 57 seconds to finish inside the Olympic qualification standard of 1 hour and 21 minutes.

The Kerala athlete holds the national record of 1:20:21 which he achieved during his 10th place finish at the 2012 Olympics in London. He also qualified for this year's World Championships as he bettered the qualifying mark of 1:22:30.

### 18-yr-old Diksha 2nd Indian golfer to win on Ladies European Tour

Eighteen-year-old Diksha Dagar became the second Indian to win an event on Ladies European Tour after clinching South African Women's Open in Cape Town. Aditi Ashok was the first Indian to win on the Ladies European Tour after clinching Hero Women's Indian Open in Gurugram in 2016. Dagar had finished tied-fifth at the NSW Open last week.

## Athletics: India finishes second in medal tally at Asian Youth C'ships

In Asian Youth Athletics Championships in Hong Kong, boys medley relay team won a gold medal for India on the final day to help Indian youth team finish second in the overall medals tally with a total of 26 medals including eight gold, nine silver and nine bronze medals.

China topped the overall medals tally with 31 medals that included 12 gold, 11 silver and eight bronze medals and Japan finished third with 20 medals that included 6 Gold, 8 Silver and 6 bronze.

# Senior journalist, environmental activist Darryl D'Monte passes away at 74

Senior journalist and environmental activist Darryl D'Monte, who worked with leading English dailies, died at a hospital in Mumbai after a brief illness. He was 74.

## **Gopi Thonakal qualifies for World Athletics Championships**

In marathon, India's Asian champion Gopi Thonakal has qualified for the World Athletics Championships to be held in the Qatari capital Doha in September-October this year. He achieved qualification after finishing 11th in the Seoul International Marathon yesterday, clocking his personal best time of 2 hours 13 minutes 39 seconds.

The Seoul International Marathon is a world class IAAF Gold label event. Gopi's time was the second best ever by an Indian after the four-decade old national record of 2 hours 12 minutes, held by Shivnath Singh. Gopi also bettered the World Championships qualification mark of 2 hrs. and 16 minutes.

### Rajasthan Royals launches cricket academy in UK

The Indian Premier League (IPL) franchise Rajasthan Royals launched its first cricket academy in the UK.

The Star Cricket Academy based at Reed's School in Surrey joined hands with Rajasthan Royals to relaunch the facility as the 'Rajasthan Royals Academy'. It has a state-of-the-art cricket centre named the Jarrett Centre with an indoor cricket training facility run by former professional batsman Siddharth Lahiri, along with his team of elite coaches including former England international and mentor to the academy, Keith Medlycott.

# India loses hosting rights of Davis Cup, Fed Cup due to closure of Pak air space

The closure of Pakistan's air space in the aftermath of the Balakot air strikes has resulted in India losing the hosting rights of the junior Davis Cup and Fed Cup. The junior Davis Cup was to be held at the DLTA complex from April 8-13 while the Fed cup matches were scheduled from April 15-20.

Both the competitions will now be held in Bangkok, Thailand.

### **Hockey India Coaching Education Pathway launched**

In an effort to develop coaches from the grassroot level and enable them to meet the requirements and the ever-growing demands of international hockey, the sport's governing body in India launched the Hockey India Coaching Education Pathway.

The meticulously designed programme aims to provide certification to those candidates who are already coaches or wish to pursue coaching as a career. The programme consists of a combination of web-based modules and face-to-face interactive courses, underpinned by a competency based assessment process.

### IPL opening ceremony funds donated to armed forces

In the wake of the Pulwama terror attacks and keeping in mind the sentiments of the people, the Supreme Court appointed Committee of Administrators (CoA), administering the BCCI, has decided to cancel the opening ceremony of the Indian Premier League (IPL) and donate the money budgeted for it to the armed forces.

"The estimated cost of hosting an IPL opening ceremony is Rs 20 crore. It was unanimously decided that a sum of Rs 11 crore be contributed to the Indian Army, Rs 7 crore to the CRPF and Rs 1 crore each to the Navy and Air Force respectively," the board said in a statement.

### World boxing chief Rahimov resigns

International Boxing Federation (AIBA) president Gafur Rahimov has resigned on the eve of the decisive IOC executive meeting, In a statement, Rahimov rejected the allegations of him having ties to organized crime and announced his resignation late on Friday, reports Xinhua news agency.

Rahimov, an Uzbek businessman who has been accused by the US authorities of having ties to organized crime, was elected the president of AIBA in November last year.

## India clinch SAFF Women's C'ship for fifth time

In football, India has clinched the SAFF Women's Championship for the fifth time in a row, defeating hosts Nepal 3-1 in the final at Biratnagar. In the first half,

Dalmia Chhibber of India scored the first goal of the match which was equalled by Nepal's Sabitra Bhandari at the 33rd minute.

In the second half, Grace Dengmei scored the second goal at 63rd minute and Anju Tamang scored third and decisive goal in the 76th minute. This was India's 23rd straight victory in the championship since its inception in 2010.

#### Suresh Raina Beats Virat Kohli, Becomes First Player To Reach 5000 Runs In IPL

As the twelfth edition of the Indian Premier League (IPL) came calling with a scintillating contest between Chennai Super Kings (CSK) and Royal Challengers Bangalore (RCB), the cricket fans geared up for multiple individual clashes that the opening match had to offer.

Amongst the key battles, there was one between Suresh Raina and the RCB skipper in the race to reach 5,000 runs in the IPL. Ahead of the IPL opener, Raina had amassed 4,985 runs in 3,601 balls (1167 dots, 1533 singles, 256 twos, 11 threes, 448 fours, 1 five and 185 sixes) in the tournament. He was just 15 runs shy of becoming the first player to score 5,000 IPL runs.

### Shotgun legend Rhode wins World Cup gold medal

The 40-year-old shotgun legend Kimberly Rhode added another gold to her enormous shooting-medal collection by claiming the title at the women's skeet event of the 2019 ISSF Shotgun World Cup here.

A total of 57 targets hit brought the American her 19th personal ISSF World Cup gold medal on Sunday. New Zealander Chloe Tipple brought home the silver with 48 hits. Zhang Donglian from China won the bronze medal.

## Savita Punia to lead Indian women's hockey team in Malaysia tour

Goalkeeper Savita will captain an 18-strong Indian women's hockey team for the five-match series against Malaysia starting from 4th of next month. Hockey India announced that Savita will stand in for regular skipper Rani Rampal, who is nursing an injury.

### Manu Bhaker-Saurabh Chaudhary bag Gold medal in 10m Air Pistol Mixed event at Asian Airgun C'ship

In Shooting, Manu Bhaker and Saurabh Chaudhary have bagged a Gold medal in the 10-metre Air Pistol Mixed team event at the 12th Asian Airgun Championship at Taoyuan in Taipei. The teenage Indian duo went on to win the five-team final with a score of 484.8 points.

The pair made it to the Final after smashing the world record in the qualification. 17-year-old Manu and 16-year-old Saurabh shot a combined score of 784, breaking the record set by Russians Vitalina Batsarashkina and Artem Chernousov at the European Championships.

### Bajrang, Rani, Pant, Bhaker receive DSJA awards

Asian Games gold medallist wrestler Bajrang Punia, hockey star Rani Rampal, cricketer Rishabh Pant and pistol shooting sensation Manu Bhaker were presented the Delhi Sports Journalists Association (DSJA) best sportspersons awards by the Indian Olympic Association (IOA) President Narinder Dhruv Batra.

### 31-year-old Hopman Cup replaced by new ATP Cup

The city of Perth in Western Australia (WA) will no longer play host to the Hopman Cup, Tennis Australia confirmed. Instead, the mixed tournament format will be replaced with an all men's event called the ATP (Association of Tennis Professionals) Cup.

Played across three cities, Perth will join Sydney and Brisbane as the hosts of the new competition which is set to feature 100 of the world's top male players.

"With 750 ATP ranking points and approximately 22 million Australian dollars (\$15.6 million) in prize money, the ATP Cup is guaranteed to attract the best international tennis players to Perth every summer," WA tourism minister Paul Papalia said.

## BCCI ombudsman Jain doubles up as ethics officer

Supreme Court-appointed BCCI ombudsman retired Justice D.K. Jain will now double up as the ethics officer of the Indian cricket board. It comes after the

Committee of Administrators (CoA) requested the apex court to appoint an ethics officer who would look into matters of conflict of interest.

### India beat Poland 10-0 at Azlan Shah Cup

**India defeated Poland** 10-0 in their final league match of Sultan Azlan Shah Cup hockey tournament at Ipoh in Malaysia .

## **Aussie football legend Tim Cahill officially retires**

After four World Cups, an illustrious club career and having risen to the rank of Australian sporting icon, **Tim Cahill** has officially quit professional football. in November, the 39-year-old announced he will no longer represent Australia at an international level even though he continued to play for Jamshedpur FC in the Indian Super League.

### Gonzalo Higuain retires from international football

**Argentine striker Gonzalo Higuain** has announced his retirement from international football at the age of 31. Higuain has not played for the Albiceleste since last year's World Cup in Russia as manager Lionel Scaloni looks to revamp his squad for this year's Copa America, reported Xinhua news agency. Higuain is sixth on the list of Argentina's all-time top scorers with 31 goals in 67 matches in an international career that spanned a decade.
