Officials from CSL claim that the ferry can handle Kochi's complex system of backwaters because of its low draft of 1 meter.

Its top speed is 12 knots, and it has a sturdy yet lightweight hull. Fire detection systems and damage stability also contribute to improved safety.

# Sudarshan Setu – India's Longest Cable-Stayed

# Bridge

Dwarka and Beyt Dwarka Island, located off the coast of Gujarat, were connected by the strategically vital Sudarshan Setu bridge, which Prime Minister Narendra Modi inaugurated on February 24, 2024.

The bridge spans the Gulf of Kutch. It surpasses all other cable-stayed road bridges in India in length, measuring over 2 km.

After changing its name from "Signature Bridge" to "Sudarshan Setu" or simply "Sudarshan Bridge," the bridge is now familiar to all.

**Overview and Budget of the Project** 

The project was overseen by the Roads and Building Department of Gujarat, and the 27meter wide four-lane bridge was approved in 2017 with an estimated cost of ₹979 crores. Larsen & Toubro oversaw the building process for six years.

The 2.32 km bridge includes a 2.45 km approach road and 900 m of central double-span cable-stayed section.

### Karnataka Leads in EV Infrastructure Development

Based on data from the Bureau of Energy Efficiency, Karnataka now has more public charging stations than any other Indian state, making it the leader in electric vehicle (EV) infrastructure development.

With the most public charging facilities for electric vehicles, Karnataka is the best: Important Things

When it comes to public EV charging stations, Karnataka is in first place with 5,059, more than both Maharashtra and Delhi combined.

When looking at the stations by state, Delhi has 1,886 and Maharashtra has 3,079 stations. Rajasthan, Uttar Pradesh, Tamil Nadu, and Kerala also have substantial populations.

With 7.45 lakh vehicles, Uttar Pradesh is the state with the highest number of electric vehicles, followed by Karnataka and Maharashtra.

When broken down by district, the 4,281 charging stations in the Bengaluru Urban district put it in first place, accounting for 85 percent of Karnataka's total.

# US Approves \$4 Billion Military Drone Sale to India

A massive \$4 billion arms deal with India has been greenlit by the US administration. A total of thirty-one MQ-9B SkyGuardian drones and associated high-tech gear would be up for grabs in the transaction.

As per the most recent tally, the demerged entity's market capitalization was Rs 1,70,331.55 crore, and it is traded on stock exchanges.

With the latest investment in RIL m-cap, the cornerstone of the Reliance business, Mukesh Ambani's fortunes soared to \$109 billion, an increase of \$12.5 billion in 2024 alone.

The Bloomberg Billionaire Index ranks him as the eleventh wealthiest person in the world and the wealthiest Indian.

After a decade of being an oil and gas legacy company, RIL has transitioned into an incubator for future firms in sectors including digital services and retail.

According to a report from BNP Paribas dated February 8, RIL has invested far more in 5G than its competitors, making it the industry leader in telecoms.

# Indian Navy's biggest military exercise 'MILAN'

The 12th edition of the MILAN exercise is scheduled to take place from today to the 27th of this month in Visakhapatnam, with the participation of more than 50 nations.

Themed **"Forging Naval Alliances for a Secure Maritime Future,"** the exercise aims to strengthen collaboration among participating navies.

One Maritime Patrol Aircraft and 15 ships from friendly foreign countries, nearly 20 ships from the Indian Navy will participate in the sea exercise. Nearly 50 aircraft including MiG 29K and P8I, aircraft carriers Vikrant and Vikramaditya will participate in the exercise.

This marks a turning point in the continuing AI arms race, as it pits Google against its rival OpenAI.

### Japan successfully launches next-gen H3 rocket

The maiden orbital launch of the next-generation H3 launch vehicle was announced by the Japan Aerospace Exploration Agency (JAXA) on February 18th, 2023.

The new flagship rocket successfully launched its test payload into its designated orbit following two unsuccessful launches in 2022.

#### **Concerning H3 Rocket**

As a replacement for the dependable H-IIA rocket used since 2001, the H3 rocket has been in development for more than ten years by JAXA and the Japanese firm Mitsubishi Heavy Industries. Adaptable and economically viable satellite launches are its intended use.

The H3 isn't reusable like the Falcon 9, but experts praise its groundbreaking technology's trial run.

# Three new moons around Uranus and Neptune

Three tiny moons, one orbiting Uranus and two circling Neptune, have been recently confirmed by the International Astronomical Union (IAU), bringing the total number of known moons to 28 around Uranus and 16 around Neptune.

#### **Tiny New Addition to Uranus**

The new Uranian moon, designated S/2023 U1 for now, is approximately 5 miles (8 kilometers) in diameter, making it one of the smallest moons in the solar system. It orbits Uranus once every 680 days. Like Uranus' other 27 moons, S/2023 U1 will eventually be given an official name from Shakespearean characters.

#### **Two More Satellites for Neptune**

The two newly confirmed Neptunian moons have been labeled S/2002 N5 and S/2021 N1. With diameters of about 14.3 miles (23 km) and 8.7 miles (14 km) respectively, they bring Neptune's total satellites to 16. S/2002 N5 takes nearly 27 years to complete one orbit, while S/2021 N1 orbits Neptune every 9 years. Following convention, they will receive names related to Greek mythology's Nereids down the line.

# Vyommitra to Precede India's Gaganyaan Mission in

### 2024

India wants to send people into space on the Gaganyaan mission in 2025. But first, a "robot friend" named Vyommitra will fly to space later this year to test important systems before humans take off.

Within the orbit of the spaceship, this female humanoid robot can act like a person.

#### What Vyommitra Says

ISRO made Vyommitra, a half-humanoid robot that weighs 40 kg and is named after the words "Vyom" for "space" and "Mitra" for "friend."

By pretending that people are on board, Vyommitra will let ISRO engineers fully test the Gaganyaan module's safety and suitability for living on before crewed trips.

Vyommitra can use several control screens inside the orbital module. It can keep an eye on factors inside the spacecraft module, let ground control know if there are any problems, and do important tasks for mission survival.

It can also use artificial intelligence to answer questions and carry on conversations during the journey. Gaganyaan will be able to take more trips to space after she is sent there.

# US Approves \$4 Billion Military Drone Sale to India

A massive \$4 billion arms deal with India has been greenlit by the US administration. A total of thirty-one MQ-9B SkyGuardian drones and associated high-tech gear would be up for grabs in the transaction.

#### **Specifics Regarding Drone Features**

In its MQ-9B, The SkyGuardian is an armed drone that can fly missions involving reconnaissance, striking, targeting, and monitoring. Important abilities consist of:

- A versatile weapon capable of destroying a wide range of maritime and land targets
- Accurate targeting using lasers
- Intelligence collection with surveillance sensors
- Able to transport missiles and laser-guided explosives
- To equip the drones for deadly attacks, the agreement also includes tiny diameter bombs and more than 300 laser-guided Hellfire missiles. The bundle is completed with state-of-the-art communication and targeting systems.

#### Sensitive technology

Dangerous computer programs, networks, and hardware are all aboard the drones. The technology might be utilized by enemies to create drone countermeasures or similar systems if they were to acquire it.

Up until Class X, students are required by the National Curriculum Framework 2023 to study three languages; two of these languages must be native Indian languages.

Between Classes XI and XII, students are encouraged to study two languages, with one of these languages also being a native Indian language.
